

RESOLUTION AUTHORIZING A CONTRACT WITH DELL MARKETING, L.P., C/O DELL MARKETING, LP, ONE DELL WAY, ROUND ROCK, TEXAS 78682 FOR THE PURCHASE OF MICROSOFT OFFICE 365 SOFTWARE FOR THE DEPARTMENT OF ADMINISTRATION, DIVISION OF MANAGEMENT INFORMATION SYSTEMS AWARDED THROUGH NEW JERSEY STATE CONTRACT #M-0003 A89850 IN AN AMOUNT NOT TO EXCEED \$78,912.00

WHEREAS, the City of Trenton, Department of Administration, Division of Management Information Systems has a need to utilize New Jersey State Contract M-0003 89850 for the purchase of Microsoft Office 365 Software awarded to Dell Marketing, L.P, One Dell Way, Round Rock, Texas 78682; and




NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
