RESOLUTION AWARDDING A CONTRACT TO GILES & RANSOME, INC., 2975 GALLOWAY RD/POB #8522, BENSALEM, PA 19020-8522 FOR THE PURCHASE OF PROPRIETARY AUTO PARTS AND MATERIALS ,VEHICLE REPAIR AND FIRE APPARATUS THROUGHOUT VARIOUS FIRE STATIONS AWARDED THROUGH NEW JERSEY STATE CONTRACT NO. T-2188 85847 IN AN AMOUNT NOT TO EXCEED \$35,000.00

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to utilize the services and make purchases without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-2188 85847 for Parts & Repairs for Road Maintenance Equipment awarded to Giles & Ransome, Inc., 2975 Galloway Rd/POB #8522, Bensalem, PA 19020-8522 extended the contract from January 30, 2018 to January 29, 2019; and

WHEREAS, the City of Trenton, Department of Fire has a need to purchase of proprietary auto parts and materials to repair vehicles and fire apparatus throughout the various fire stations on an needed basis awarded through New Jersey State Contract No. T-2188 85847; and

WHEREAS, funds in amount not to exceed \$35,000.00 have been certified to be available in account number 8-01- -45-4500-265 contingent upon the adoption FY'2018 final budget.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order in an amount not to exceed \$35,000.00 to Giles & Ransome, Inc., 2975 Galloway Rd/POB #8522, Bensalem, PA 19020-8522 for the purchase of proprietary auto parts and materials to repair vehicles and fire apparatus throughout the various fire stations on an needed basis for the City of Trenton, Fire Department.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
