

**RESOLUTION AUTHORIZING A CONTRACT TO ACRO SERVICE CORPORATION,
 39209 WEST SIX MILE ROAD, SUITE 250, LIVONIA, MICHIGAN 48152
 TO PROVIDE TEMPORARY STAFFING SERVICES ON AN AS NEEDED BASIS FOR THE
 DEPARTMENT OF FINANCE THROUGH NEW JERSEY STATE CONTRACT NUMBER
 M-2001 83534 IN AN AMOUNT NOT TO EXCEED \$20,000.00**

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to utilize temporary staff services without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the contract awarded to Acro Service Corporation, 32909 W. Six Mile Rd., Suite 250, Livonia, MI 48152 has been extended from April 1, 2017 to March 31 2018 through New Jersey State Contract M-2001 83534. The Division of Purchasing has reviewed and verified New Jersey State Cooperative Purchasing Program No. M-2001 83534 for Temporary Staffing Services meeting the requirements of the City of Trenton, Department of Finance, Division of Tax Assessment; and

WHEREAS, the City of Trenton, Department of Finance has a need for clerical assistance and would like to utilize the temporary staffing services awarded to Acro Service Corporation, 32909 W. Six Mile Rd., Suite 250, Livonia, MI 48152 through New Jersey State Contract M-2001 83534 on an as needed basis from October 1, 2017 to March 31 2018; and



NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:


1. The Purchasing Agent is hereby authorized to execute a purchase order to Acro Service Corp, 3929 W. Six Mile Rd., Suite 250, Livonia, MI 48152 in an amount not to exceed \$20,000.00 to provide temporary staffing services for the City of Trenton, Department of Finance, Division of Tax Assessment.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
