RESOLUTION AWARDING A CONTRACT TO MERCER SPRING & ALIGNMENT, 215 MIAMI AVENUE, TRENTON, NEW JERSEY 08610 FOR MAINTENANCE AND REPAIR FOR HEAVY DUTY VEHICLES (CLASS 5 OR HIGHER, OVER 15,000 LB GVWR) AWARDED THROUGH STATE CONTRACT NO. T-2108 89285 IN AN AMOUNT NOT TO EXCEED \$20,000.00

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to utilize the services and make purchases without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-2108 89285 for maintenance and repair for heavy duty vehicles (Class 5 or Higher, over 5,000 LB GVWR) awarded to Mercer Spring & Alignment, 215 Miami Ave, Trenton, NJ 08610 awarded from July 21, 2015 to July 20, 2018; and

WHEREAS, the City of Trenton, Department of Fire has a need for maintenance and repair for heavy duty vehicles (Class 5 or Higher, over 15,000 LB GVWR) through New Jersey State Contract No. T-2108 89285 for the City of Trenton, Fire Department; and

WHEREAS, funds in amount not to exceed \$20,000.00 have been certified to be available in account number 8-01- -45-4500-265 contingent upon the adoption FY'2018 final budget from October 12, 2017 to June 30, 2018.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order in an amount not to exceed \$20,000.00 to Mercer Spring & Alignment, 215 Miami Ave, Trenton, NJ 08610 for maintenance and repair for heavy duty vehicles (Class 5 or Higher, over 15,000 LB GVWR) for the City of Trenton, Fire Department from October 12, 2017 to June 30, 2018.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
