





RESOLUTION AWARDING A CONTRACT WITH BUCKS COUNTY INTERNATIONAL, 134 OLD OXFORD VALLEY ROAD, LANGHORNE, PA 19047 FOR MAINTENANCE AND REPAIR FOR HEAVY DUTY VEHICLES (CLASS 5 OR HIGHER, OVER 15,000LBS GVWR) AWARDED THROUGH STATE CONTRACT NO. T-2108 89266 IN AN AMOUNT NOT TO EXCEED \$25,000.00

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton for the Maintenance and Repair of Heavy Duty Vehicles (Class 5 or Higher, over 15,000lbs GVWR) without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract T-2108 A89266 awarded to Bucks County International, 134 Old Oxford Valley Road, Langhorne, PA 19047 for Maintenance and Repair for Heavy Duty Vehicles (Class 5 or Higher, over 15,000lbs GVWR) awarded from July 21, 2015 to July 20, 2018; and

WHEREAS, the City of Trenton, has a need to utilize State Contract T-2108 89266 for Maintenance and Repair of Heavy Duty Vehicles (Class 5 or Higher, over 15,000lbs GVWR), on an as needed basis awarded to Bucks County International, 134 Old Oxford Valley Road, Langhorne, PA 19047; and


WHEREAS, funds in amount not to exceed \$25,000.00 have been certified to be available in account number 08-01- -55-5510-265 contingent upon FY'18 final budget from October 5, 2017 to July 7, 2018.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order in an amount not to exceed \$25,000.00 to Bucks County International, 134 Old Oxford Valley Road, Langhorne, PA 19047 for Maintenance and Repair of Heavy Duty Vehicles (Class 5 or Higher, over 15,000lbs GVWR) for the City of Trenton, Department of Public Works, Division of Solid Waste Management from October 5, 2017 to July 20, 2018.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
