RESOLUTION AUTHORIZING CHANGE ORDER #1 TO THE CONTRACT WITH GZA GEOENVIRONMENTAL, INC., TO PROVIDE FOR THE INVESTIGATION AND REMEDIAL ACTION PLANNING AT THE FORMER NEW METHOD CLEANERS SITE, 300-310 PROSPECT STREET

WHEREAS, Resolution 17-212 authorized a contract with GZA GeoEnvironmental, Inc., awarded through a fair and open process, to provide state-mandated professional services in accordance with NJDEP regulations, to investigate and plan for future remediation of this contaminated former dry cleaning site, to the City of Trenton, in the amount of \$125,715.00; and

WHEREAS, during the performance of the contract conditions were discovered that resulted in the requirement to conduct additional sampling and related work to meet the requirements of state environmental regulations for contaminated groundwater plume delineation and related reporting; and

WHEREAS, the changes will not alter the contract in such a manner as to nullify the effect of the competitive determination which was made at the time of the contract award; and

WHEREAS, the amount of this change order is \$24,557. No previous change orders have been authorized. The total amount of this change order is less than 20% of the original contract amount; and

WHEREAS, funds have been certified to be available in grant capital account C-04-10-60-035B-002-001 (\$24,557.00);

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that Change Order #1 to the contract with GZA GeoEnvironmental Inc. is hereby authorized.

**RESOLUTION # 18-793
CHANGE ORDER #1
RFP2016-31**

THE AGREEMENT made this 21ST day of DECEMBER 2018, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **GZA GEOENVIRONMENTAL, INCORPORATION, 55 LANE ROAD, SUITE 407, FAIRFIELD, NEW JERSEY 07004** (hereinafter "CONTRACTOR")

WHEREAS, Resolution 17-212 awarded a contract on May 5, 2017, to GZA Geoenvironmental, Incorporation, 501 Office Center Drive, Suite 220, Fort Washington, Pennsylvania 19034 to Conduct a Remedial Investigation, Remedial Action Selection and Remedial Action Planning of the Former New Method Dry Cleaners in an amount not to exceed \$125,715.00 for a Period of One (1) Year from May 5, 2017 to May 4, 2018 for the City of Trenton, Department of Housing and Economic Development; and

WHEREAS, during the performance of the contract conditions were discovered that resulted in the requirement to conduct additional sampling and related work to meet the requirements of state environmental regulations for contaminated groundwater plume delineation and related reporting; and

WHEREAS, Resolution No. #18-793 dated December 20, 2018, authorized Change Order No. #1 in an amount not to exceed \$24,557.00; No previous change orders have been authorized in the amount of #0.00. The total amount of this and previous change orders is 20% of the original contract amount; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$24,557.00. The changes will not alter the contract in such a manner as to nullify the effect of the competitive determination of lowest responsible bidder which was made at the time of the contract award; and
2. The Mayor is hereby authorized Change Order No. #1 with GZA Geoenvironmental, Incorporation, 55 Lane Road, Suite 407, Fairfield, New Jersey 07004 for said purposes in the manner prescribed by law. The grand total for this project is \$150,272.00.
