



RESOLUTION AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH THE LAW OFFICES OF WEINER LAW GROUP, LLP, 629 PARSIPPANY ROAD, P.O. BOX 0438, PARSIPPANY, NEW JERSEY 07051 TO PROVIDE CONTINUED PROFESSIONAL LEGAL SERVICES REGARDING GENERAL MUNICIPAL AND DEFENSE LITIGATION MATTERS IN AN AMOUNT NOT TO EXCEED \$60,000.00

WHEREAS, the City of Trenton has a continuing need for professional legal services regarding General Municipal and Defense Litigation matters; and

WHEREAS, Resolution Number 17-402 awarded a contract to Weiner Law Group, LLP in an amount not to exceed \$90,000.00 through RFP2017-17 and Resolution Number 18-64 amended the contract in an amount of \$50,000.00; and

WHEREAS, all previously allocated funds has been exhausted and additional funds are necessary to cover services through June 2018; and


WHEREAS, this amendment shall be awarded to Weiner Law Group, LLP in an amount not to exceed \$60,000.00; and


WHEREAS, funds for this contract have been certified to be available in the Law Department's FY2018 Budget, Account No. 8-01- -35-3500-290; and

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to amend the contract with the Law Office of Weiner Law Group, LLP for the said purposes in the manner prescribed by law.

AMENDMENT TO PROFESSIONAL LEGAL SERVICES AGREEMENT

THIS AMENDED AGREEMENT made this 17th day of May 2018, by and between the **CITY OF TRENTON**, a municipal corporation of the State of New Jersey, with its principal offices located at 319 East State Street, Trenton, New Jersey 08608 (herewith the ‘City’) and **WEINER LAW GROUP, LLP**, 629 Parsippany Road, P.O. Box 0438, Parsippany, New Jersey 07051 (hereinafter ‘Law Firm’).

WHEREAS, based upon the number of hours which the Law Firm has expended in the 2018 fiscal contract year in the performance of general and municipal litigation defense on behalf of the City ; and

WHEREAS, the compensation initially allocated by the City to compensate the Law Firm has been deemed to be insufficient to the end of the fiscal contract year; and


WHEREAS, pursuant to Resolution **18-269**, the City desires to increase the compensation under the current Professional Services Agreement for said services through June 30, 2018,

NOW THEREFORE, the parties mutually agree as follows:

1. The compensation amount of the Agreement shall be increased by an amount not to exceed (\$60,000.00)
2. All other provisions of the Professional Legal Services Agreement executed on July 1, 2017 shall remain in full force and effect.
