**RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO TRI-COUNTY SECURITY, 1142 EAST CHESTNUT AVENUE, SUITE A, VINELAND, NEW JERSEY 08630 TO PROVIDE ONE (1) ADULT CROSSING GUARD AT THE INTERSECTION OF ROUTE 129 AND LALOR STREET FOR THE TRENTON POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED 63,336.00 – BID2016-42**

**WHEREAS**, Resolution No. 16-504 awarded a contract on August 18, 2016 to Tri-County Security, Inc., 1142 E. 

**RESOLUTION # 18-379  
EXERCISING THE OPTION TO EXTEND A CONTRACT FOR TWO (2) YEARS  
WITH TRI-COUNTY SECURITY, INC.  
BID2016-42**

**THE AGREEMENT** made this 19<sup>TH</sup> day of JANUARY 2018, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **TRI-COUNTY SECURITY, INC., 1142 E. CHESTNUT AVENUE, SUITE A, VINELAND, NEW JERSEY 08360** (hereinafter "CONTRACTOR")

**WHEREAS**, Resolution 16-504 awarded a contract on August 18, 2016 to Tri-County Security, Inc., 1142 E. Chestnut Avenue, Suite A, Vineland, New Jersey 08360 for to Provide One (1) Adult Crossing Guard at the Intersection of Route 129 and Lalor Street in an amount not to exceed \$63,336.00 for a period of two (2) years from July 1, 2016 to June 30, 2018 with an Option to Extend Two (2) Years for the City of Trenton, Police Department; and

**WHEREAS**, Resolution No. #18-379 dated June 7, 2018, authorized the option to extend the contract for two (2) years in an amount not to exceed \$126,672.00 per the original bid specifications filed in the Division of Purchasing.

**NOW THEREFORE**, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$126,672.00 from July 1, 2018 to June 30, 2020.
2. The Mayor is hereby authorized to exercise the two (2) years option to extend the contract with Tri-County Security, Inc., 1142 E. Chestnut Avenue, Suite A, Vineland, New Jersey 08360 for said purposes in the manner prescribed by law.
