RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR ONE (1) YEAR AWARDED TO REVENUE SERVICES, LLC, 2751 DIXWELL AVENUE, 4TH FLOOR, HAMDEN, CT 06518 FOR DELINQUENT TAX COLLECTIONS SERVICES FOR THE CITY OF TRENTON, DEPARTMENT OF FINANCE, DIVISION OF TAX IN AN AMOUNT NOT TO EXCEED \$200,000.00 PER YEAR WITH A FEE STRUCTURE BASED ON 13.49% OF THE AMOUNT OF TAX LIEN COLLECTED - BID2017-37

WHEREAS, Resolution No. 17-582 awarded a contract on September 7, 2017, to Revenue Services, LLC, 2751 Dixwell Avenue, 4th Floor, Hamden, CT 06518 for Delinquent Tax Collections Services in an amount not to exceed \$200,000.00 per year with a fee structure based on 13.49% of the amount of tax lien collected for the City of Trenton, Finance, Division of Tax; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Finance, Division of Tax has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year to Revenue Services, LLC, 2751 Dixwell Avenue, 4th Floor, Hamden, CT 06518 in an amount not exceed \$200,000.00 per year with a fee structure based on 13.49% of the amount of tax lien collected; and

WHEREAS, funds in an amount not to exceed \$200,000.00 for the option to extend the third (3) year have been certified to be available in the following account number(s): 00-01- -30-3040-290 contingent upon the FY'2020 temporary and or final budget.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to exercise the option to extend the contract for the third (3) year with Revenue Services, LLC, 2751 Dixwell Avenue, 4th Floor, Hamden, CT 06518 in an amount not exceed \$200,000.00 per year with a fee structure based on 13.49% of the amount of tax lien collected for the City of Trenton, Department of Finance, Division of Tax for the said purposes in the manner prescribed by law.

EXERCISING THE OPTION TO EXTEND A CONTRACT
WITH REVENUE SERVICES, LLC
BID2017-37

THE AGREEMENT made this 21st day of JUNE 2019, by and between the CITY OF TRENTON, a municipal corporation, of the State of New Jersey, with principal offices located at 319 EAST STATE STREET, TRENTON, NEW JERSEY 08608 (hereinafter the "City") and REVENUE SERVICES, LLC, 2751 DIXWELL AVENUE, 4TH FLOOR, HAMDEN, CT 06518 (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 18-07 dated January 16, 2018, awarded a contract to The Liberty Store, 5 East Genesee Street, Auburn, New York 13021 for the Furnishing and Delivery F.O.B. of Uniforms and Footwear in an amount not to exceed \$55,420.48 for a Period of One (1) Year from January 17, 2018 to January 16, 2019 from with an Option to Extend One (1) Year from January 18, 2019 to January 17, 2020 for the City of Trenton, Department of Finance, Division of Tax; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that services may be extended for no more than (1) one two-year (2) two one-year extensions; and

WHEREAS, The City of Trenton, has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year to The Liberty Store, 5 East Genesee Street, Auburn, New York 13021 in an amount not exceed \$55,420.48; and

NOW THEREFORE, the parties mutually agree as follows:


1. The amount of the agreement shall be in an amount not to exceed \$55,420.48.
