



**RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR ONE (1) YEAR  
AWARDED TO BRENNTAG NORTHEAST INC., 81 WEST HULLER LANE, READING, PA 19605  
FOR THE FURNISHING AND DELIVERY OF POTASSIUM PERMANGANATE  
IN AN AMOUNT NOT TO EXCEED \$324,174.68- BID 2017-55**

**WHEREAS**, Resolution No. 17-723 awarded a contract on October 31, 2017, to Brenntag Northeast, Inc., 81 West Huller Lane, Reading, PA 19605 for the Furnishing and Delivery of Potassium Permanganate (KMn04) for a period of one (1) year in an amount not to exceed \$324,174.68 for a unit price per drum at \$810.4367 (for KMn04) with an option to extend one (1) year for the City of Trenton, Department of Public Works, Trenton Water Utility; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and


**WHEREAS**, The City of Trenton, Department of Water & Sewer has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year from July 1, 2019 to June 30, 2020 to Brenntag Northeast Inc., 81 West Huller Lane, Reading, PA 19605 in an amount not exceed \$324,174.68 at a unit price per drum at \$810.4367 (for KMn04); and



**RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO  
BRENTAG NORTHEAST, INC, 81 WEST HULLER LANE, READING, PA 19605  
FOR THE FURNISHING AND DELIVERY OF POTASSIUM PERMANGANATE  
IN AN AMOUNT NOT TO EXCEED \$324,174.68- BID2017-55**

WHEREAS, five (5) sealed bids were received on July 12, 2017, for the furnishing and delivery of potassium permanganate (KMnO4) for a period of one (1) year with an option to extend one (1) year for the City of Trenton, Department of Public Works, Trenton Water Utility; and

WHEREAS, the bid specifications required that the potassium permanganate (KMnO4) be manufactured in the USA. The bids of Marubeni Specialty Chemicals, Inc, George S. Coyne Chemical, Inc. and Shannon Chemical Corporation are considered non-responsive for failure to be in compliance with the specifications. The three (3) low bidder's potassium permanganate is manufactured in India. The bidders were notified in writing; and

WHEREAS, the fourth bidder's potassium permanganate (KMnO4) is manufactured in the USA. Brentag Northeast, Inc., 81 West Huller Lane, Reading, PA 19605 made pursuant to advertisement, be and is hereby accepted, as the responsive, responsible bidder complying with terms and specifications on file in the Division of Purchasing; and

WHEREAS, funds in an amount not to exceed \$324,174.68 for a period of one (1) year have been certified to be available in accounts 8-05-55-5500-821-012 contingent upon the adoption FY'2018 final budget with an option to extend one (1) year at the same price contingent upon the availability of FY'19 temporary or final budget.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to execute a contract with Brentag Northeast, Inc., 81 West Huller Lane, Reading, PA 19605 for the furnishing and delivery of potassium permanganate (KMnO4) manufactured in the USA for the City of Trenton, Department of Public Works, Trenton Water Utility for the said purposes in the manner prescribed by law.

EXERCISING THE OPTION TO EXTEND A CONTRACT  
WITH BRENNTAG NORTHEAST INC.  
BID2017-55

THE AGREEMENT made this 21st day of JUNE 2019, by and between the CITY OF TRENTON, a municipal corporation, of the State of New Jersey, with principal offices located at 319 EAST STATE STREET, TRENTON, NEW JERSEY 08608 (hereinafter the "City") and BRENNTAG NORTHEAST INC., 81 WEST HULLER LANE, READING, PA 19605 hereinafter "CONTRACTOR")

WHEREAS, Resolution No. #17-723 dated October 31, 2017, awarded a contract to Brenntag Northeast Inc., 81 West Huller Lane, Reading, PA 19605 for the Furnishing and Delivery of Potassium Permanganate (KMn04) for a period of one (1) year in an amount not to exceed \$324,174.68 for a unit price per drum at \$810.4367 (for KMn04) for a Period of One (1) Year from November 1, 2017 to October 31, 2018 from with an Option to Extend One (1) Year options from July 1, 2019 to June 30, 2020 for the City of Trenton, Department of Public Works, Trenton Water Utility; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that services may be extended for no more than (1) one two-year (2) two one-year extensions; and

WHEREAS, The City of Trenton, has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year to Brenntag Northeast Inc., 81 West Huller Lane, Reading, PA 19605 in an amount not to exceed \$324,174.68 for a unit price per drum at \$810.4367 (for KMn04); and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$324,174.68 for a unit price per drum at \$810.4367 (for KMn04) from July 1, 2019 to June 30, 2020.
2. The Mayor is hereby authorized to extend the contract, with Brenntag Northeast Inc., 81 West Huller Lane, Reading, PA 19605 for the Furnishing and Delivery of Potassium Permanganate (KMn04) in an amount not to exceed \$324,174.68 for a unit price per drum at \$810.4367 (for KMn04) upon the adoption FY'2020 temporary and or final budget for said purposes in the manner prescribed by law.


