**RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR ONE (1) YEAR AWARDED TO KUEHNE CHEMICAL CO., INC., 86 NORTH HACKENSACK AVENUE, SOUTH KERNEY, NEW JERSEY 07032 FOR THE FURNISHING AND DELIVERY OF SODIUM HYPOCHLORITE IN AN AMOUNT NOT TO EXCEED \$220,200.00- BID 2018-30**

**WHEREAS**, Resolution No. 18-398 awarded a contract on June 7, 2018, to Kuehne Chemical Co., Inc., 86 North Hackensack Avenue, South Kearny, New Jersey 07032 for the Furnishing and Delivery of Sodium Hypochlorite for a period of one (1) year in an amount not to exceed \$207,570.00 for a unit price per gallon at \$0.6919 for 300,000 gallons with an option to extend one (1) year for the City of Trenton, Department of Public Works, Trenton Water Utility; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

**WHEREAS**, The City of Trenton, Department of Water & Sewer has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year from July 1, 2019 to June 30, 2020 to Kuehne Chemical Co., Inc., 86 North Hackensack Avenue, South Kearny, New Jersey 07032 in an amount not exceed \$220,200.00 for a unit price per gallon at \$0.734 for 300,000 gallons; and





**RESOLUTION # 19-290  
EXERCISING THE OPTION TO EXTEND A CONTRACT  
WITH KUEHNE CHEMICAL CO., INC.,  
BID2018-30**

**THE AGREEMENT** made this 21st day of **JUNE 2019**, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **KUEHNE CHEMICAL CO., INC., 86 NORTH HACKENSACK AVENUE, SOUTH KERNEY, NEW JERSEY 07032** hereinafter "CONTRACTOR")

**WHEREAS**, Resolution No. #18-398 dated June 7, 2018, awarded a contract to Kuehne Chemical Co., Inc., 86 North Hackensack Avenue, South Kerney, New Jersey 07032 for the Furnishing and Delivery of Sodium Hypochlorite for a period of one (1) year in an amount not to exceed \$207,570.00 for a unit price per gallon at \$0.6919 for 300,000 gallons for a Period of One (1) Year from June 8, 2018 to June 7, 2019 from with an Option to Extend One (1) Year options from July 1, 2019 to June 30, 2020 for the City of Trenton, Department of Public Works, Trenton Water Utility; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-15 provides that services may be extended for no more than (1) one two-year (2) two one-year extensions; and

**WHEREAS**, The City of Trenton, has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for a period of one (1) year to Kuehne Chemical Co., Inc., 86 North Hackensack Avenue, South Kerney, New Jersey 07032 in an amount not to exceed \$220,000.00 for a unit price per gallon at \$0.734 for 300,00 gallons; and

**NOW THEREFORE**, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$220,000.00 for a unit price per gallon at \$0.734 for 300,00 gallons.
2. The Mayor is hereby authorized to extend the contract, with Kuehne Chemical Co., Inc., 86 North Hackensack Avenue, South Kerney, New Jersey 07032 for the Furnishing and Delivery of Sodium Hypochlorite in an amount not to exceed \$220,000.00 for a unit price per gallon at \$0.734 for 300,00 gallons upon the adoption FY'2020 temporary and or final budget for said purposes in the manner prescribed by law.
