RESOLUTION REJECTING BID RECEIVED FOR LEASE OF SPACE FOR CELLULAR ANTENNA SYSTEM ON THE WATER TOWERS BID2019-46

WHEREAS, one (1) sealed bid was received on July 18, 2019, for Lease of Space for Cellular Antenna System on the Water Towers located at Elmore & Clifford Avenue, Hamilton, Block S501, Lot 121 a/k/a Mercerville Water Tank; and/or 1 Darrah Lane, Lawrence Township, Block 3301, Lot 29 a/k/a Lawrence Water Tank for the City of Trenton, Department of Administration; and

WHEREAS, on July 18, 2019, the sole bid received from Sprint Spectrum, L.P. did not agree to the 4% rent increase specified in the bid specifications and the incorrect bid was submitted; and

WHEREAS, it is in the best interest of the City to reject this bid received from Sprint Spectrum, L.P. and re-advertise this procurement process; and

NOW, THEREFORE, IT IS RESOLVED, by the City Council of Trenton that the bid received be rejected and the Division of Purchasing will re-advertise the procurement process.
