RESOLUTION AUTHORIZING A CONTRACT EXTENSION TO MAJESTIC OIL COMPANY, INC., 2104 FAIRFAX AVENUE, CHERRY HILL, NEW JERSEY 08003-1624 FOR THE FURNISHING AND DELIVERY OF DIESEL FUEL, ULTRA LOW SULFUR AND WINTER MIX ON AN AS NEEDED BASIS FOR VARIOUS DEPARTMENTS/DIVISIONS IN THE CITY OF TRENTON THROUGH THE NEW JERSEY STATE CONTRACT SC# T-1845 A82767 IN AN AMOUNT NOT TO EXCEED \$134,962.01

WHEREAS, Resolution 16-750 authorized the option to extend the contract for the purchase of diesel fuel, ultra low sulfur and winter mix on an needed basis for various divisions of the City of Trenton from Majestic Oil Company, Inc., in an amount not to exceed \$412,000.00 from November 1, 2016 to October 31, 2017; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-1845 A82767 extending the contract to Majestic Oil, Inc., 2104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 from March 1, 2018 to August 31, 2018; and

WHEREAS, said, ultra low sulfur diesel fuel, ultra low sulfur diesel fuel dyed, and winter mix at a cost based on the daily fluctuating prices as posted in the Oil Price Daily, an OPIS Publication. This base price is based upon the average of the low and high Newark ULS Diesel and ULS Diesel Dyed postings, in correlation to the type of fuel delivered, plus one of four delivery charges based upon the range of gallons delivered: +.1.5697 for less than 1000 gallons, =.1.5678 for 1001-2500 gallons, =.1.601 for 2501-5000 gallons and *.1.6014 for greater than 5001 gallons; March 1, 2018 to August 31, 2018; and

WHEREAS, funds in an amount not to exceed \$134,962.01 have been certified to be available in account numbers for FY'2018 final budget and contingent upon the adoption of FY'19 temporary and or final budget.

CONTRACT EXTENSION TO MAJESTIC OIL COMPANY, INC

THE AGREEMENT made this **20TH Day of DECEMBER 2018**, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **MAJESTIC OIL COMPANY, INC., 2104 FAIRFAX AVENUE, CHERRY HILL, NEW JERSEY 08003-1624** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 18-360 authorized the option to extend the contract for the purchase of diesel fuel, ultra-low sulfur and winter mix on an as needed basis to various divisions for the City of Trenton from Majestic Oil Company, Inc., 3104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 in an amount not to exceed \$134,962.01 from March 1, 2018 to August 31, 2018 through State Contract No. T-1845 82767; and

WHEREAS, Resolution No. 18-789 extended a contract to Majestic Oil Company, Inc., 3104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 for the purchase of diesel fuel, ultra-low sulfur and winter mix on an as needed basis to various divisions in the City of Trenton from September 1, 2018 to May 31, 2019 in an amount not to exceed \$174,806.48 through State Contract No. T-1845 82767; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-1845 82767 extending the contract to Majestic Oil, Inc., 2104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 from September 1, 2018 to May 31, 2019; and

WHEREAS, said, ultra-low sulfur diesel fuel, ultra-low sulfur diesel fuel dyed, and winter mix at a cost based on the daily fluctuating prices as posted in the Oil Price Daily, an OPIS Publication. This base price is based upon the average of the low and high Newark ULS Diesel and ULS Diesel Dyed postings, in correlation to the type of fuel delivered, plus one of four delivery charges based upon the range of gallons delivered: +.1.5697 for less than 1000 gallons, =.1.5678 for 1001-2500 gallons, =.1.601 for 2501-5000 gallons and *.1.6014 for greater than 5001 gallons; September 1, 2018 to May 31, 2019; and

WHEREAS, the City of Trenton has determined that Majestic Oil, Inc., 2104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for the furnishing and delivery of gasoline, automotive from September 1, 2018 to May 31, 2019 through New Jersey State Contract T-1845 82767; and


NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$174,806.48.
2. The Mayor is hereby authorized to extend the contract for eight (8) months with Majestic Oil, Inc., 2104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 from September 1, 2018 to May 31, 2019 for said purposes in the manner prescribed by law.
