

**RESOLUTION # 19-26
CHANGE ORDER #1
RFP2017-15**

THE AGREEMENT made this 19TH day of APRIL 2019, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **SOVEREIGN CONSULTING, INC., 111-A NORTH GOLD DRIVE, ROBBINSVILLE, NEW JERSEY 08691-1646** (hereinafter "CONTRACTOR")

WHEREAS, Resolution 17-593 awarded a contract on September 7, 2017, to Sovereign Consulting, Inc., 111-A North Gold Drive, Robbinsville, New Jersey 08691-1646 for the Completion of a Remedial Investigation Workplan, Remedial Action Workplan and State Required LSRP Professional Services in an amount not to exceed \$81,906.00 for the City of Trenton, Department of Housing and Economic Development for a Period of One (1) Year from date of award; and

WHEREAS, Resolution No. #19-26 dated April 18, 2019, authorized Change Order No. #1 in an amount not to exceed \$15,886.00; previous change orders have been authorized in the amount of #0.00. The total amount of this and previous change orders is 20% of the original contract amount; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$15,886.00. The changes will not alter the contract in such a manner as to nullify the effect of the competitive determination of lowest responsible bidder which was made at the time of the contract award; and
2. The Mayor is hereby authorized Change Order No. #1 with Sovereign Consulting, Inc., 111-A North Gold Drive, Robbinsville, New Jersey 08691-1646 for said purposes in the manner prescribed by law. The grand total for this project is \$15,866.00.

NOW THEREFORE, the parties mutually agree as follows:

3. The amount of the agreement shall be in an amount not to exceed \$15,866.00. The changes will not alter the contract in such a manner as to nullify the effect of the competitive determination of lowest responsible bidder which was made at the time of the contract award; and
4. The Mayor is hereby authorized Change Order No. #1 with Sovereign Consulting, Inc., 111-A North Gold Drive, Robbinsville, New Jersey 08691-1646 for said purposes in the manner prescribed by law.

RESOLUTION AUTHORIZING CHANGE ORDER #1 TO THE CONTRACT WITH SOVEREIGN CONSULTING, INC., TO PROVIDE FOR ADDITIONAL ENVIRONMENTAL INVESTIGATION AND REMEDIAL ACTION PLANNING AT THE ROEBLING BLOCK 2 SITE

WHEREAS, Resolution 17-593 authorized a contract with Sovereign Consulting, Inc., awarded through a fair and open process, to provide state-mandated professional services in accordance with NJDEP regulations, to investigate, plan and oversee future remediation of this contaminated former industrial site, to the City of Trenton, in the amount of \$81,906.00; and

WHEREAS, during the performance of the contract conditions were discovered that resulted in the requirement to conduct additional sampling and related work to meet the requirements of state environmental regulations for contaminated soil investigation and delineation; and

WHEREAS, the changes will not alter the contract in such a manner as to nullify the effect of the competitive determination which was made at the time of the contract award; and

WHEREAS, the amount of change order #1 is \$15,886.00. No previous change orders have been authorized. The total amount of this change order is less than 20% of the original contract amount; and

WHEREAS, funds have been certified to be available in grant account G-SS-93-60-086B-290 (\$15,886.00);

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that Change Order #1 to the contract with Sovereign Consulting, Inc. is hereby authorized.

RESOLUTION AWARING A CONTRACT THROUGH A FAIR AND OPEN PROCESS IN ACCORDANCE WITH N.J.S.A. 19:44 A-20.4 ET SEQ TO SOVEREIGN CONSULTING, INC., 111-A NORTH GOLD DRIVE, ROBBINSVILLE, NEW JERSEY 08691-1646 FOR THE COMPLETION OF A REMEDIAL INVESTIGATION WORKPLAN, REMEDIAL ACTION WORKPLAN AND STATE REQUIRED LSRP PROFESSIONAL SERVICES FOR ROEBLING BLOCK 2 IN AN AMOUNT NOT TO EXCEED \$81,906.00- RFP2017-15

WHEREAS, the City of Trenton has a need for Professional Services for Remedial Investigation Workplan, Remedial Investigation, Remedial Action Workplan and State-required LSRP (Professional) services for Roebling Block 2 for the Department of Housing & Economic Development for a period of one (1) year from date of award; and

WHEREAS, a request for proposals was advertised, and sixteen (16) proposals were received on May 25, 2017 and were evaluated by a committee based on criteria that included, experience, understanding of requirements and cost; and

WHEREAS, the proposal of Sovereign Consulting Inc., 111-A North Gold Drive, Robbinsville, New Jersey 08691-1646 was deemed to have the necessary qualifications and expertise for the performance of the services at the rates budgeted; and

WHEREAS, funds in an amount not to exceed \$81,906.00 have been certified to be available in grant account number G-SS-93-60-086B-290.

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Trenton, that:

1. The Mayor is authorized to enter into a contract with Sovereign Consulting Inc., 111-A North Gold Drive, Robbinsville, New Jersey 08691-1646 for a period of one (1) year from date of award in an amount not to exceed \$81,906.00.
2. This contract is awarded pursuant to the authority set forth in the Local Public Contracts Law at N.J.S.A. 40A:11-5.
3. A notice of this action shall be printed once in the official newspaper for the City of Trenton and the Resolution and contract shall remain on file in the City Clerk's Office.
