1. In the Introduction, Section C, item 4, and in Item 5 of the Proposal Page, states that MARS Company provides "Plumbing installation of new test benches and recirculation system". MARS Company only provides
the plumbing connectivity and materials for the Recirculation System only (connections to/from the Recirculation System and to/from the Test Benches). Trenton is responsible for the plumbing required for the supply of water into the Supply Tank. In addition, Trenton Water Works is responsible for the removal of
certain blocks from the wall(s) to run the MARS-provided piping.
2. Electrical requirements are attached (CAD drawing).
3. As software licensing is not addressed within the bid specifications, MARS Company attaches the MARS End User License Agreement to incorpoate as part of the Contract.
4. Section VI, Item 2., Construction Contacts, does not apply as we are re-assembling the MARS System.
Trenton is responsible for the plumbing to the Supply Tank, electrical to the designated points and to provide the
boring / displacement of the blocks in the wall for the required connections.
5. Additional MARS Terms and Conditions are attached to include details such as Acceptance, Warranty and
Operational Control
