
Please accept this correspondence as my interest in the above referenced RFP to provide Public Defender services in Trenton City Municipal Court.

I am available to accommodate any Trenton City Municipal Court session and any meetings that are scheduled. I am respectfully requesting compensation in the amount of \$215.00 per session.


