2. REIMBURSABLE EXPENSES FOR ADDITIONAL SERVICES

- A. Consultants which are not part of a proposal, such as structural, civil, hydraulic, kitchen, etc., will be billed at a rate of 1.3 times the amounts billed to our office.
- B. Reproduction of documents by outside vendors will be billed at the rate of 1.5 times the cost billed to our office. In-house reproduction of drawings will be billed at \$0.50/sq. ft. Plotter usage will be billed at \$40.00 per plot. Computer CD of drawings at \$250.00.
- C. Express mail or overnight messenger services are billed at 1.5 times the cost billed to our office.

3. INVOICES

- A. Invoices will be submitted monthly. Billing will be based on the actual hours expended or the percentage of work completed, as provided in the Owner/Architect agreement. Invoices are payable within thirty (30) days.
- B. Any invoice or portion thereof that is not satisfied within thirty (30) days will be subject to interest charges of 1.5% per month. If we do not receive payment as per our invoices, we reserve the right to suspend any further services.

Assumptions & Exclusions

1. Our fee is based on professional A/E services for the expansion and renovation of the Municipal Court.
2. Professional fees and work excludes Survey, Site/Civil Engineering, Site Design, Parking Design, Environmental Engineering (inclusive of testing of hazardous materials and soils testing), Landscape Architecture, Exterior Signage and Traffic Engineering.
3. Our fee proposal is based on producing one set of construction documents for the purpose of a bidding a single project. Should the project not be constructed under one contract, Clarke Caton Hintz will seek compensation for additional services.



ORIGINAL

The fee includes general LEED design in order to submit for a LEED- Silver rating. Excludes third party commissioning, which shall be obtained by Owner. Excludes solar/photovoltaic design, BIM design, energy modeling, computerized energy analysis and life cycle costs, commissioning and/or assisting commissioning agents in their preparation of calculations and documentation, start-up, training, etc.

5. Excludes engineering as follows: Specialty lighting design, specialty acoustical design, food service, etc.
6. MEP/ Fire work will be limited to changes in distribution only. It is assumed that the base building systems and head-end equipment are adequate and still within their overall life expectancy. If the City elects to modernize the base building systems and head-end equipment, CCH will seek additional compensation.

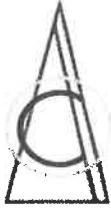

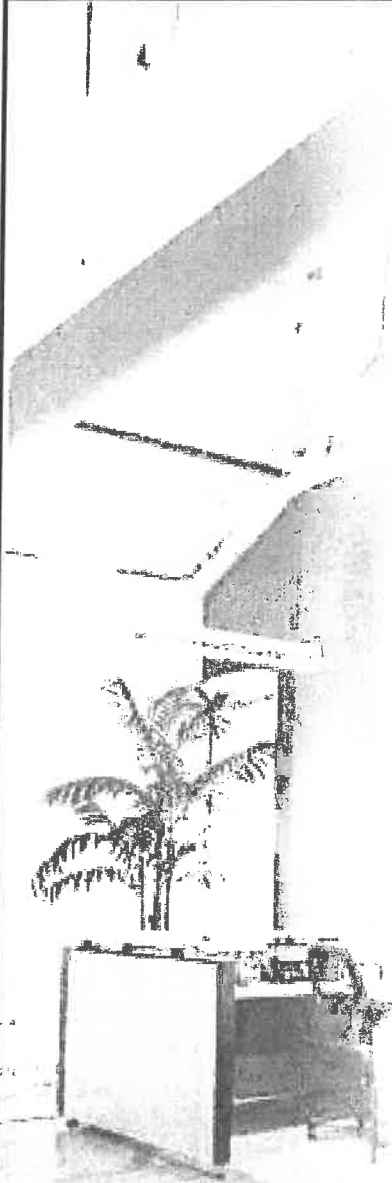
