Such diagram shall also show the location and candle power of all the lights in the emergency courts.

The applicant hereby acknowledges that he has full knowledge of the provisions of all ordinances of the City of Trenton and laws of the State of New Jersey regulative of and affecting the business for which application for license is hereby made, and such applicant agrees to observe and be bound by all the provisions of said ordinance and laws, and the limitations, terms and conditions thereof in as full and complete a matter as the case would be if such provisions, limitations, terms and conditions were printed in length upon the license certificate, and that such license certificate, if issued to the applicant, will be subject to all provisions of said ordinances and laws and the limitations, terms and conditions

contained therein, and also to any terms, limitations and conditions endorsed which may be imposed by the Director of Public Safety of the City of Trenton as a condition precedent to his recommending the granting of a license.
