

**RESOLUTION # 19-600
EXERCISING THE OPTION TO EXTEND A CONTRACT
WITH MERIDIAN PROPERTY SERVICES, INC.
BID2018-37**

THE AGREEMENT made this 15TH day of NOVEMBER 2019, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **MERIDIAN PROPERTY SERVICES., INC., 3024 SOUTH BROAD STREET, HAMILTON, NEW JERSEY 08610** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 18-503 awarded a contract on August 2, 2018, to Starling Electric, LLC, 865 Lower Ferry Road, Suite #115, Ewing New Jersey, 08628 (\$75.00 per hour) and Meridian Property Services, Inc., 3024 South Broad Street, Hamilton, New Jersey 08610 (\$107.24 per hour) for On-Call Electrical Services and Repairs at Various City of Trenton Facilities in an amount not to exceed \$45,000.00 for a period of one (1) year with an option to extend one (1) year for the City of Trenton, Department of Public Works, Division of Public Property; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Public Works, Division of Public Property has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract from November 15, 2019 to November 14, 2020 to Meridian Property Services, Inc., 3024 South Broad Street, Hamilton, New Jersey 08610 at an hourly rate \$110.46 per hour with an overtime rate at \$165.69 per hour on an as needed basis; and

WHEREAS, the City of Trenton has determined that Meridian Property Services, Inc., 3024 South Broad Street, Hamilton, New Jersey 08610 has performed its services in a satisfactorily manner and it is in the best interest of the City to extend the contract for On-Call Electrical Services and Repairs at Various City of Trenton Facilities for the City of Trenton, Department of Public Works, Division of Public Property; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be funds in an amount not to exceed \$45,000.00 for the City of Trenton, Department of Public Works, Division of Public Property from November 15, 2019 to November 14, 2020.
2. The Mayor is hereby authorized to exercise the option to extend the contract for the second (2) Year from November 15, 2019 to November 14, 2020 with Meridian Property Services, Inc., 3024 South Broad Street, Hamilton, New Jersey 08610 in an amount not to exceed \$45,000.00 at an hourly rate \$110.46 per hour with an overtime rate at \$165.69 per hour for On-Call Electrical Services and Repairs at Various City of Trenton Facilities for the City of Trenton, Department of Public Works, Division of Public Property for the said purposes in the manner prescribed by law.






