RESOLUTION AUTHORIZING TO CANCEL CONTRACT AND RESOLUTION #19-499 AWARDED TO GOLDEN, INC.

WHEREAS, Resolution #19-499 was awarded on September 5, 2019, to Golden, Inc., 4816 North Warnock Street, Philadelphia, PA 19141 for Cleaning Services at Trenton Water Distribution Center Complex, 333 Cortland Street, Trenton, New Jersey in an amount not to exceed \$29,900.00 for a period of one (1) year with an option to extend one (1) year for the Department of Water and Sewer; and.

WHEREAS, Golden, Inc., was not able to fulfill the specification requirements for the Department of Water Distribution Center Complex. The cleaning schedule was not in compliance with the bid specifications and requirements filed in the Division of Purchasing; and

WHEREAS, the City of Trenton met with Golden, Inc. on February 3, 2020; and both parties agreed that the company was not able to meet the specification requirements on a day-to-day basis; and

WHEREAS, it is in the best interest of the City of Trenton to cancel Resolution #19-499 and the contract awarded to Golden, Inc., 4816 North Warnock Street, Philadelphia, PA 19141 and re-bid this procurement.

NOW, THEREFORE, IT IS RESOLVED by the City Council of the City of Trenton that the Mayor is hereby authorized to cancel Resolution #19-499 and contract awarded to Golden, Inc., 4816 North Warnock Street, Philadelphia, PA 1914 in an amount not to exceed \$29,900.00 for the said purposes in the manner prescribed by law.
