**RESOLUTION AWARDING A CONTRACT EXTENSION TO RIGGINS, INC.,  
P.O. BOX 150, MILLVILLE, NEW JERSEY 08360 FOR THE FURNISHING AND  
DELIVERY OF UNLEADED 87 OCTANE GASOLINE ON AN AS NEEDED BASIS FOR  
VARIOUS DEPARTMENTS/DIVISIONS THROUGH NEW JERSEY STATE CONTRACT  
NO. T-0083 19-FLEET-00969 IN AN AMOUNT NOT TO EXCEED \$261,782.08**

WHEREAS, Resolution Number 19-267 extended a contract to Riggins, Inc., P.O. Box 150, Millville, New Jersey 08360 for the furnishing and delivery of unleaded 87 octane gasoline on an as needed basis to various departments/divisions in the City of Trenton from June 1, 2019 to November 30, 2019 in an amount not to exceed \$82,668.48 through State Contract No. T-0083 19-FLEET-00969; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-0083 A80909 based on Oil Price Information Service (OPIS) for the date of the fuel plus a constant up at a cost per gallon at \$1.5231 plus a constant delivery of gasoline, automotive from June 1, 2019 to November 30, 2019 on as needed basis through State Contract No. T-0083 19-FLEET-00969; and

WHEREAS, the City of Trenton has determined that Riggins, Inc., P.O. Box 150, Millville, New Jersey 08368 has performed its services in a satisfactorily manner and it is in the best interest of the City to extend the contract for the furnishing and delivery of gasoline, automotive from December 1, 2019 to June 30, 2020 through New Jersey State Contract T-0083 19-FLEET-00969; and

WHEREAS, the New Jersey State Contract No. T-0083 19-FLEET-00969 has extended its contract period from December 1, 2019 to June 30, 2020. The City is extending the contract to coincide with the State contract period; and

CONTRACT EXTENSION  
WITH RIGGINS, INC.  
STATE CONTRACT: T-0083 19-FLEET-00969

THE AGREEMENT made this 7TH day of FEBRUARY 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter "the" City) and **RIGGINS, INC., P.O. BOX 150, MILLVILLE, NEW JERSEY 08360** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 19-267 extended a contract to Riggins, Inc., P.O. Box 150, Millville, New Jersey 08360 for the furnishing and delivery of unleaded 87 octane gasoline on an as needed basis to various departments/divisions in the City of Trenton from June 1, 2019 to November 30, 2019 in an amount not to exceed \$82,668.48 through State Contract No. T-0083 19-FLEET-00969; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-0083 A80909 based on Oil Price Information Service (OPIS) for the date of the fuel plus a constant up at a cost per gallon at \$1.5231 plus a constant delivery of gasoline, automotive from June 1, 2019 to November 30, 2019 on as needed basis through State Contract No. T-0083 19-FLEET-00969; and

WHEREAS, The City of Trenton has determined that Riggins, Inc., P.O. Box 150, Millville, New Jersey 08638 has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract from December 1, 2019 to June 30, 2020 on an as needed basis through State Contract No. T-0083 19-FLEET-00969; and

WHEREAS, the New Jersey State Contract No. T-0083 19-FLEET-00969 has extended its contract from December 1, 2019 to June 30, 2020. The City is extending the contract to coincide with the State period; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be funds in an amount not to exceed \$261,782.08 for the City of Trenton, from December 1, 2019 to May 14, 2020.
2. The Mayor is hereby authorized to extend the contract for a period of one (1) year from December 1, 2019 to November 14, 2020 with Riggins, Inc., P.O. Box 150, Millville, New Jersey 08638 in an amount not to exceed \$261,782.08 for the furnishing and delivery of unleaded 87 octane gasoline on an as needed basis to various departments/divisions in the City of Trenton for the said purposes in the manner prescribed by law.
