



RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR ONE (1) YEAR AWARDED TO FOLEY, INC. IN AN AMOUNT NOT TO EXCEED \$74,840.40– BID 2018-75

WHEREAS, Resolution No. 18-797 awarded a contract on December 20, 2019, to Foley, Inc., 855 Centennial Avenue, Piscataway, New Jersey 08854 for Natural Gas Engine Generator Maintenance for Central Pumping Station Located at Pennington and Mellon Streets, Trenton, New Jersey in an amount not to exceed \$74,840.40 (for items#1-8) for year one (1); with an option to extend year two (2) at \$74,840.40 (for items#1-8) from July 1, 2019 to June 30, 2020 for the City of Trenton, Department of Water and Sewer; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Water and Sewer has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for the second (2) year from time of award to June 30, 2020 to Foley, Inc., 855 Centennial Avenue, Piscataway, New Jersey 08854 in an amount not exceed \$74,840.40 for items#1-8; and





CONTRACT EXTENSION
WITH FOLEY, INC.

THE AGREEMENT made this **19TH day of MARCH 2020**, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **FOLEY, INC., 855 CENTENNIAL AVENUE, PISCATAWAY, NEW JERSEY 08854** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 18-797 awarded a contract on December 20, 2019, to Foley, Inc., 855 Centennial Avenue, Piscataway, New Jersey 08854 for Natural Gas Engine Generator Maintenance for Central Pumping Station Located at Pennington and Mellon Streets, Trenton, New Jersey in an amount not to exceed \$74,840.40 (for items#1-8) for year one (1); with an option to extend year two (2) at \$74,840.40 (for items#1-8) from July 1, 2019 to June 30, 2020 for the City of Trenton, Department of Water and Sewer; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Water and Sewer has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for the second (2) year from time of award to June 30, 2020 to Foley, Inc., 855 Centennial Avenue, Piscataway, New Jersey 08854 in an amount not exceed \$74,840.40 for items#1-8; and

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be funds in an amount not to exceed \$74,840.40 for items#1-8 for the City of Trenton, Department of Water and Sewer from March 20, 2020 to June 30, 2020.
2. The Mayor is hereby authorized to enter into a contract extension for the second (2nd) year from March 20, 2020 to June 30, 2020 with Foley, Inc., 855 Centennial Avenue, Piscataway, New Jersey in an amount not to exceed \$74,840.00 (for items#1-8) for Natural Gas Engine Generator Maintenance for Central Pumping Station Located at Pennington and Mellon Streets, Trenton, New Jersey for the City of Trenton, Department of Water and Sewer for the said purposes in the manner prescribed by law.
