
**WHEREAS**, no additional funds are being utilized for the contract extension.

**RESOLUTION AWARDING A CONTRACT TO CAROUSEL INDUSTRIES OF NORTH AMERICA, INC., 1160 STILFORD AVENUE, PLAINFIELD, NEW JERSEY 07060 TO PROVIDE ANNUAL MAINTENANCE SERVICES FOR THE E911 PATRIOT TELEPHONE SYSTEM THROUGH NEW JERSEY STATE CONTRACT NUMBER T-1776 A85946 IN AN AMOUNT NOT TO EXCEED \$110,000.00**

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items and provide services without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract Number # T-1776 A85946 for Data Communications Network Services awarded to Carousel Industries of North America, Inc., 1160 Stilford Avenue, Plainfield, New Jersey 07060 from February 11, 2014 to February 10, 2020 meeting the requirements of the City of Trenton, Department of Police; and

**WHEREAS**, Carousel Industries of North America, Inc., 1160 Stilford Avenue, Plainfield, New Jersey 07060 shall provide Annual Maintenance Services for the E911 Patriot Telephone System in the Communication Divisions that meets the department requirements awarded through New Jersey State Contract Number # T-0106 A85946 from July 1, 2019 to February 10, 2020 in an amount not to exceed of \$110,000.00 for the City of Trenton, Department of Police; and

**WHEREAS**, funds in an amount not to exceed \$110,000.00 have been certified to be available in the following account numbers(s): 0-01- -50-5010-270; funds will be available in the final adopted budget for the City of Trenton.

**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:

The Purchasing Agent is hereby authorized to execute a purchase order in an amount not to exceed \$110,000.00 to provide Annual Maintenance Services for the E911 Patriot Telephone System in the Communication Division awarded through New Jersey State Contract Number # T-1776 A85946 to Carousel Industries of North America, Inc., 1160 Stilford Avenue, Plainfield, New Jersey 07060 for the City of Trenton, Department of Police from July 1, 2019 to February 10, 2020.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
