CONTRACT EXTENSION
WITH GENERAL CHEMICAL AND SUPPLY
BID2019-30

THE AGREEMENT made this **22ND day of MAY 2020**, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **GENERAL CHEMICAL AND SUPPLY, 858 NORTH LENOLA ROAD, MOORESTOWN, NEW JERSEY 08057** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 19-335 awarded a contract on July 2, 2019, to General Chemical and Supply, 858 North Lenola Road, Moorestown, New Jersey 08057 for the Furnishing and Delivery of Janitorial Supplies in an amount not to exceed \$49,000.00 for a period of one (1) year from July 1, 2019 to June 30, 2020; with an option to extend year one (1) at \$49,000.00 from July 1, 2020 to June 30, 2021 for the City of Trenton, Department of Public Works, Division of Public Property; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Public Works, Division of Public Property has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for one (1) year from July 1, 2020 to June 30, 2021 to General Chemical and Supply, 858 North Lenola Road, Moorestown, New Jersey 08057 in an amount not exceed \$49,000.00; and

NOW THEREFORE, the parties mutually agree as follows:

1. The Mayor is hereby authorized to extend the contract for one (1) year from July 1, 2020 to June 30, 2021 with General Chemical and Supply, 858 North Lenola Road, Moorestown, New Jersey 08057 for the City of Trenton, Department of Public Works, Division of Public Property for the said purposes in the manner prescribed by law.
