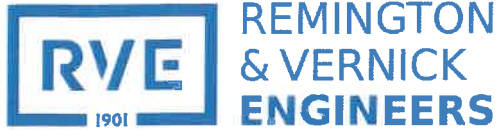

REMINGTON & VERNICK ENGINEERS, INC. (RVE) is pleased to submit this proposal to provide supplemental design services of the Wash Bay for the City of Trenton (City). This proposal has been prepared in accordance with the specifications set forth in the City’s Request for Proposals (RFP). In general, the supplemental work efforts requested by the City includes engineering and design services for a surveillance and security system for the facility and engineering and design services for a roof mounted Photovoltaic system and surveillance and security system for the facility. RVE is best suited to provide these services due to being the lead designer of the original truck wash bay project.

**Supplemental Engineering & Design Services**

The supplemental work efforts associated with this aspect of the professional services for the project are for:

- Professional services for the provision of a surveillance and security system infrastructure in the proposed wash bay. This will include, but not necessarily limited to, new security cameras, card readers, access controls, and all other associated equipment. RVE will coordinate with the City for requirements the installation of new equipment.
- Professional services for the provision of a roof mounted Photovoltaic System at the vehicle wash facility. RVE will design the panel layout, additional roof supporting structure, inverters, cabling, and all other components of the roof mounted solar array. It is our understanding that the City will be purchasing and operating the system independently and will not be seeking to lease the system through a “Power Purchase Agreement (PPA)”.
