




RESOLUTION AUTHORIZING THE USE OF COMPETITIVE CONTRACTING IN LIEU OF PUBLIC BIDDING FOR PUBLIC HEALTH SUPPORT SERVICES

WHEREAS, N.J.S.A. 40A:11-4.1 et seq., authorizes the use of competitive contracting in lieu of public bidding for procurement of specialized goods and services for certain enumerated purposes identified therein; and

WHEREAS, N.J.S.A. 40A:11-4.4, et seq., specifies requirements as to the term of contracts, the solicitation process, the request for proposals documentation and the methodology and criteria to be used to be used in evaluating proposals submitted; and


WHEREAS, the purpose for the use of competitive contracting herein is for The City of Trenton's Division of Health is required by State Statute to provide Public Health Services that are compliant with the Public Health Practice Standards of Performance in N.J.A.C. 8:52. The City must meet requirements for guidelines listed as "Essential Public Health Services" activities detailed in N.J.A.C. 8:52-3.1, 3.2. The practice of public health in New Jersey is defined by the programs and capacities to provide services as set forth in N.J.A.C. 8:52-3.2(A) and shall be ensured by each local board of health for each of its residents, in accordance with this regulation. To that end, the City is soliciting sealed proposals through a fair and open process in accordance with N.J.S.A. 1944a-20.4 et seq from professional health care management and consulting organizations, to provide staff support and assistance in the provision of specified "essential public health services." The City of Trenton must comply with the statutory (N.J.S.A. 40A:11-4.1k through 4.5) and regulatory (N.J.A.C.5:34-4.1 et seq.) provisions of the process. The term of the contract shall not exceed five (5) years.

NOW, THEREFORE IT IS RESOLVED, by the City Council of the City of Trenton that the Purchasing Agent is hereby authorized to utilize the competitive contracting process for Public Health Support Services for the City of Trenton, Department of Health and Human Services pursuant to N.J.S.A. 40A:11-4.1.k -et seq
