

**AMENDMENT TO RESOLUTION 19-166
WITH CDM SMITH
CC2019-01**

THE AMENDED AGREEMENT made this 18TH day of SEPTEMBER 2020, by and between the **CITY OF TRENTON**, a Municipal Corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **CDM SMITH, 110 FIELDCREST AVENUE #8, 6TH FLOOR, EDISON, NEW JERSEY 08837** (hereinafter "Professional Services").

WHEREAS, Resolution 19-166 dated April 18, 2019, awarded a contract to CDM Smith, 110 Fieldcrest Avenue #8, 6th Floor, Edison, New Jersey 08837 for Professional Services for Lead ACO Compliance-Corrosion Control, Lead Line Service Replacement Program and Public Education for a period of three (3) years for the City of Trenton, Department of Water and Sewer, Trenton Water Works per specifications filed in the Division of Purchasing; and

WHEREAS, Resolution No. 20-319, amended the contract due on September 18, 2020 to additions to the scope of services which includes: an increase in the number of originally contracted sequential sampling sites as mandated by New Jersey Department of Environmental Protection ("DEP") to improve sequential sampling coverage in TWW's system; an increase in the originally contracted GIS data collection efforts to include LSL registration data management and lead material inspection data management; increased design and construction management efforts to ensure the successful completion and operation of the orthophosphate feed system serving the gravity area; and a re-bid of the LSL Replacement Contract for Phase 1A due to unforeseen delays from the DEP and the Local Finance Board; and

WHEREAS, due to an increase in TWW staffing, TWW can now provide a resident project representative for part of the CCT construction over sight for a savings of \$41,770.00; TWW can also provide a resident project representative for the LSL Replacement Program construction oversight for the Utility-Side Only Contract for a savings of \$96,720.00; door-to-door outreach activities for now being conducted by TWW staff, and TWW has found other effective means of communicating with its customers, therefore, many subtasks are no longer needed, resulting, resulting in a savings of \$31,519.00; and

WHEREAS, this results in a Project Scope net increase in the amount of \$113,056.00; and

NOW THEREFORE, the parties mutually agree as follows:

1. The Mayor is hereby authorized to execute an amended contract with CDM Smith, 110 Fieldcrest Avenue #8, 6th Floor, Edison, New Jersey 08837 Professional Services for Lead ACO Compliance-Corrosion Control, Lead Line Service Replacement Program and Public Education for the City of Trenton, Department of Water and Sewer, Trenton Water Works grand total of the project in an amount not to exceed \$1,931,739.00 and the project scope net increase in an amount not to exceed \$113,056.00 for a grand total of \$2,044,795.00.
2. The amended contract shall remain in full force from September 18, 2020 to September 17, 2023 and shall not be extended without approval of the City Council of the City of Trenton.



RESOLUTION AMENDING THE CONTRACT WITH CDM SMITH TO PROVIDE PROFESSIONAL SERVICES FOR LEAD ACO COMPLIANCE-CORROSION CONTROL, THE LEAD SERVICE LINE REPLACEMENT PROGRAM FOR THE CITY OF TRENTON IN AN AMOUNT NOT TO EXCEED \$113,056

WHEREAS, Resolution 19-166 authorized a contract for CDM Smith to provide Professional Services for Lead ACO Compliance-Corrosion Control ("CCT"), a Lead Service Line ("LSL") Replacement Program to the City of Trenton, Department of Water and Sewer, Trenton Water Works ("TWW"), in the amount of \$1,931,739.00 (See Attachment A, Resolution 19-166); and

WHEREAS, the LSL and CCT Programs are two of the most complex capital projects ever undertaken by TWW, and, as they evolve, they will require adjustments throughout the term of the contract; and

WHEREAS, additions to scope include: an increase in the number of originally contracted sequential sampling sites as mandated by New Jersey Department of Environmental Protection ("DEP") to improve sequential sampling coverage in TWW's system; an increase in the originally contracted GIS data collection efforts to include LSL registration data management and lead material inspection data management; increased design and construction management efforts to ensure the successful completion and operation of the orthophosphate feed system serving the gravity area; and a re-bid of the LSL Replacement Contract for Phase 1A due to unforeseen delays from the DEP and the Local Finance Board; and

WHEREAS, due to an increase in TWW staffing, TWW can now provide a resident project representative for part of the CCT construction oversight for a savings of \$41,770; TWW can also provide a resident project representative for the LSL Replacement Program construction oversight for the Utility-Side Only Contract for a savings of \$96,720; door-to-door outreach activities are now being conducted by TWW staff, and TWW has found other effective means of communicating with its customers, therefore, many subtasks are no longer needed, resulting in a savings of \$31,519; and

WHEREAS, this results in a Project Scope net increase in the amount of \$113,056; and

WHEREAS, the contract (PO #19-08264) was awarded through a fair and open process in accordance with N.J.S.A. 19:44 et seq.; and

WHEREAS, funds have been certified to be available in capital account number C-06-20-55-024D-302, LCR Compliance.





WHEREAS, funds in an amount not to exceed \$1,931,739.00 shall be available in the following account number 09-05- 55-5500-899 for a period of three (3) years contingent upon the adoption of the FY'2019 temporary and or final budget.


NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:


