

**AMENDMENT TO RESOLUTION 20-581  
WITH THE LAW OFFICE OF TRIMBOLI & PRUSINOWSKI, LLC  
RFP2019-18**

**THE AMENDED AGREEMENT** made this 1ST day of OCTOBER 2020, by and between the **CITY OF TRENTON**, a Municipal Corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **THE LAW OFFICE OF TRIMBOLI & PRUSINOWSKI, LLC, 268 SOUTH STREET, MORRISTOWN, NEW JERSEY 07960** (hereinafter "Professional Services").

**WHEREAS**, Resolution 19-422 was adopted and awarded on August 1, 2019, through a fair and open process in accordance per N.J.S.A. 19:44 A-204 Et. Seq to The Law Office of Trimboli & Prusinowski, LLC, 268 South Street, Morristown, New Jersey 07960 to provide Professional Legal Services Regarding Labor & Employment Matters in an amount not to exceed \$75,000.00 and structured at the hourly rate as follows, \$175.00 for Partners, \$135.00 for Associate Attorneys and \$85.00 for Paralegals for a period of one (1) year from July 1, 2019 to June 30, 2020; and

**WHEREAS**, Contract Amendment No. 1 to bring the total price of the contract from \$75,000.00 to \$91,000.00 to continue to provide Professional Legal Services Regarding Labor & Employment Matters; and

**WHEREAS**, Resolution No. 20-57, amended the awarded amount on Resolution #19-422; from \$75,000.00 to \$91,000.00 awarded to The Law Office of Trimboli & Prusinowski, LLC, 268 South Street, Morristown, New Jersey 07960; and

**NOW THEREFORE**, the parties mutually agree as follows:

1. The Mayor is hereby authorized to execute an amended contract with The Law Office of Trimboli & Prusinowski, LLC, 268 South Street, Morristown, New Jersey 07960 to provide Professional Legal Services Regarding Labor & Employment Matters for the City of Trenton, Department of Administration in an amount not to exceed \$91,000.00 at the hourly rate as follows, \$175.00 for Partners, \$135.00 for Associate Attorneys and \$85.00 for Paralegals.
2. The amended contract shall remain in full force from February 21, 2020 to February 20, 2021 and shall not be extended without approval of the City Council of the City of Trenton.






**WHEREAS**, funds for this contract have been certified to be available in account 0-01- -25-2500-290; and,
