THE AGREEMENT made this 16<sup>TH</sup> day of OCTOBER 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **GREER LIME COMPANY, P.O. BOX 1900, MORGANTOWN, WV 26507** (hereinafter "CONTRACTOR")

**WHEREAS**, Resolution No. 19-493 awarded a contract on October 3, 2019, to Greer Lime Company, P.O. Box 1900, Morgantown, WV 26507 for the Furnish and Delivery of Quicklime in an amount not to exceed \$122,136.00 at a unit price per ton of \$174.48 (700 tons) for a period of one (1) year from July 1, 2019 to June 30, 2020; with an option to extend for one (1) year in an amount not to exceed \$122,136.00 at a unit price of \$122,136.00 at a unit price per ton of \$174.48 (700 tons) from July 1, 2020 to June 30, 2021 for the City of Trenton, Department of Water and Sewer, Division of Water Filtration Plant; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

**WHEREAS**, The City of Trenton, Department of Water and Sewer, Water Filtration Plant has determined that the vendor has performed its delivery services in a satisfactory manner and it is in the best interest of the City to exercise the option to extend the contract for a period of one (1) year from July 1, 2020 to June 30, 2021 to Greer Lime Company, P.O. Box 1900, Morgantown, WV 26507 in an amount not exceed \$122,136.00 at a unit price per ton of \$174.48 (700 tons); and

**NOW THEREFORE**, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$122,136.00 at a unit price per ton of \$174.48 (700 tons) for the City of Trenton, Department of Water and Sewer, Water Filtration Plant from July 1, 2020 to June 30, 2021.
2. The Mayor is hereby authorized to enter into a contract extension for one (1) year from July 1, 2020 to June 30, 2021 with Greer Lime Company, P.O. Box 1900, Morgantown, WV 26507 be in an amount not to exceed \$122,136.00 at a unit price per ton of \$174.48 (700 tons) for the Furnish and Delivery of Quicklime for the City of Trenton, Department of Water and Sewer, Water Filtration Plant for the said purposes in the manner prescribed by law.
