**THE AGREEMENT** made this 30<sup>TH</sup> day of OCTOBER 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **ATLANTIC COAST POLYMER, INC., 6207 BEE CAVES ROAD, SUITE 180, AUSTIN, TEXAS 78746** (hereinafter "CONTRACTOR")

**WHEREAS**, Resolution No. 19-612 awarded a contract on October 8, 2019, to Atlantic Coast Polymer, Inc., 6207 Bee Caves Road, Suite 180, Austin, Texas 78746 for the Furnish and Delivery of Sludge Blanket Polymer in an amount not to exceed \$133,900.00 at a unit price per ton of \$515.00 per drum for 14,300 gallons for a period of one (1) year from November 15, 2019 to November 14, 2020; with an option to extend one (1) year in an amount not to exceed \$139,100.00 at a unit price of \$535.00 per drum for 14,300 gallons from date of award to November 14, 2021 for the City of Trenton, Department of Water and Sewer, Division of Water Filtration Plant; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

**WHEREAS**, The City of Trenton, Department of Water and Sewer, Water Filtration Plant has determined that the vendor has performed its delivery services in a satisfactory manner and it is in the best interest of the City to exercise the option to extend the contract for a period of one (1) year from October 29, 2020 to November 14, 2021 to Atlantic Coast Polymer, Inc., 6207 Bee Caves Road, Suite 180, Austin, Texas 78746 in an amount not to exceed \$139,100.00 at a unit price of \$535.00 per drum for 14,300 gallons; and

**NOW THEREFORE**, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$139,100.00 at a unit price per ton of \$535.00 per drum for 14,300 gallons for the City of Trenton, Department of Water and Sewer, Water Filtration Plant from October 29, 2020 to November 14, 2021.
2. The Mayor is hereby authorized to enter into a contract extension for one (1) year from October 29, 2020 to November 14, 2021 with Atlantic Coast Polymer, Inc., 6207 Bee Caves Road, Suite 180, Austin, Texas 78746 in an amount not to exceed \$139,100.00 at a unit price per ton of \$535.00 per drum for 14,300 gallons for the Furnish and Delivery Sludge Blanket Polymer of Trenton, Department of Water and Sewer, Water Filtration Plant for the said purposes in the manner prescribed by law.
