

AMENDMENT TO RESOLUTION 20-466
WITH GALLS
STATE CONTRACT: #T-0046 20-FOOD-00904

THE AMENDED AGREEMENT made this 25TH day of NOVEMBER 2020, by and between the **CITY OF TRENTON**, a Municipal Corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **GALLS, 1340 RUSSELL CAVE ROAD, LEXINGTON, KENTUCKY 40505** (hereinafter "Professional Services").

WHEREAS, Resolution #20-466 dated September 17, 2020, was awarded to Galls, 1340 Russell Cave Road, Lexington, Kentucky 40505 for Protective Clothing and Footwear meeting the requirements of the City of Trenton, Department of Fire and Emergency Services through New Jersey State Contract No. T-0046 20-FOOD-00904 in an amount not to exceed \$65,000.00; The State has awarded this contract from April 21, 2017 to April 20, 2021; and

WHEREAS, during this contract period the Department of Fire and Emergency Services has reviewed and monitored the department's expenditures throughout the fiscal year 2020. The Department of Fire and Emergency Services has a need for additional fund for annual purchase, repair and cleaning of uniforms; and

WHEREAS, it is in the best interest of the City of Trenton to amend Resolution #20-466 to add an additional \$35,000.00 for repetitive purchasing of uniforms, cleaning and repair of uniforms for the Department of Fire and Emergency Services; and

NOW THEREFORE, the parties mutually agree as follows:

1. The Mayor is hereby authorized to amend Resolution #20-466 and award a contract with Galls, 1340 Russell Cave Road, Lexington, Kentucky 40505 for the annual purchase, repair and cleaning of uniforms for the City of Trenton, Department of Fire and Emergency Services in an amount not to exceed \$35,000.00.
2. The amended contract shall remain in full force from July 1, 2020 to June 30, 2021 and shall not be extended without approval of the City Council of the City of Trenton.







NOT TO EXCEED \$65,000.00**

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Cooperative Purchasing Program T-0046 Contract No. 20-FOOD-00904 for Protective Clothing and Footwear meeting the requirements of the City of Trenton, Department of Fire and Emergency Services. The State of New Jersey has awarded this contract from April 21, 2017 to April 20, 2021; and



2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
