THE AGREEMENT made this 23RD day of DECEMBER 2020, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **MAJESTIC OIL COMPANY, INC., 2104 FAIRFAX AVENUE, CHERRY HILL, NEW JERSEY 08003-1624** (hereinafter "CONTRACTOR")

WHEREAS, Resolution 19-320 authorized the contract extension for the purchase of diesel fuel, ultra low sulfur and winter mix on an as needed basis for various departments/divisions of the City of Trenton from Majestic Oil Company, Inc., 2104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 in an amount not to exceed 135,960.44 from June 1, 2019 to December 31, 2019; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Public Works, Division of Public Property determined that the vendor has performed for furnishing and delivery of diesel fuel, ultra low sulfur diesel fuel dyed, and winter mix a satisfactory manner and it is in the best interest of the City is extending the contract for an additional one (1) year from October 30, 2020 to October 29, 2021 to Majestic Oil Company, Inc., 2104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 in an amount not exceed \$233,075.04; and


NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$233,075.04 for the City of Trenton, Department of Public Works, Division of Public Property from October 30, 2020 to October 29, 2021.
2. The Mayor is hereby authorized to enter into a contract extension for one (1) year from October 30, 2020 to October 29, 2021 with Majestic Oil Company, Inc., 2104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 in an amount not to exceed \$233,075.04 furnishing and delivery of diesel fuel, ultra low sulfur diesel fuel dyed, and winter mix for the City of Trenton, Department of Public Works, Division of Public Property for the said purposes in the manner prescribed by law.

RESOLUTION AUTHORIZING A CONTRACT EXTENSION TO MAJESTIC OIL COMPANY, INC., 2104 FAIRFAX AVENUE, CHERRY HILL, NEW JERSEY 08003-1624 FOR THE FURNISHING AND DELIVERY OF DIESEL FUEL, ULTRA LOW SULFUR AND WINTER MIX ON AN AS NEEDED BASIS FOR VARIOUS DEPARTMENTS/DIVISIONS IN THE CITY OF TRENTON THROUGH THE NEW JERSEY STATE CONTRACT T1845 19-FOOD-01098 IN AN AMOUNT NOT TO EXCEED \$233,075.04

WHEREAS, Resolution 19-320 authorized the option to extend the contract for the purchase of diesel fuel, ultra low sulfur and winter mix on an as needed basis for various departments/divisions of the City of Trenton from Majestic Oil Company, Inc., in an amount not to exceed 135,960.44 from June 1, 2019 to December 31, 2019; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Cooperative Purchasing Program T1845 19-FOOD-01098 for Ultra-Low Sulfur Diesel and Biodiesel Fuel meeting the requirements of the City of Trenton, Department of Public Works, Division of Public Property. The State of New Jersey has awarded this contract from April 1, 2020 to March 31, 2025; and

WHEREAS, N.J.S.A. 40A:11-12 (a) permits any contracting unit under this act may without advertising for bids, or having rejected all bids obtained pursuant to advertising therefore, purchase any goods or services under any contract or contract for such goods or services entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, the City of Trenton, Department of Public Works, Division of Public Property has a need to award a contract to Majestic Oil, Inc., 2104 Fairfax Avenue, Cherry Hill, New Jersey 08003-1624 for the furnishing and delivery of diesel fuel, ultra low sulfur diesel fuel dyed, and winter mix awarded through New Jersey State Cooperative Program T-1845 19-FOOD-01098 from October 30, 2020 to October 29, 2021; and

WHEREAS, said, ultra low sulfur diesel fuel, ultra low sulfur diesel fuel dyed, and winter mix at a cost based on the daily fluctuating prices as posted in the Oil Price Daily, an OPIS Publication. This base price is based upon the average of the low and high Newark ULS Diesel and ULS Diesel Dyed postings, in correlation to the type of fuel delivered, plus one of four delivery charges based upon the range of gallons delivered: +.1.5697 for less than 1000 gallons, =.1.5678 for 1001-2500 gallons, =.1.601 for 2501-5000 gallons and *.1.6014 for greater than 5001 gallons; October 30, 2020 to October 29, 2021; and

WHEREAS, funds in an amount not to exceed \$233,075.04 have been certified to be available in account numbers for FY'2021 final budget and contingent upon the adoption of FY'2022 temporary and or final budget.






