**RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO
KEEP IT CLEAN JANITORIAL SERVICES AND SUPPLY COMPANY FOR CLEANING
SERVICE AT TRENTON WATER WORKS DISTRIBUTION COMPLEX MULBERRY AND
COURTLAND STREET FOR A PERIOD OF ONE (1) YEAR FROM DATE OF AWARD IN
AN AMOUNT NOT TO EXCEED \$36,557.20 BID 2021-63**

WHEREAS, seven (7) sealed bids were received on September 17, 2021, for Cleaning Services at Trenton Water Works Distribution Complex Mulberry and Courtland Street for a period of one (1) year for the City of Trenton, Department of Water and Sewer.

WHEREAS, this contract is required for the daily cleaning, sanitizing and trash removal of the Trenton Water Works Distribution Complex, Mulberry and Courtland Street at 333 Courtland Street, Trenton, New Jersey 08618; and

WHEREAS, the low bidder, Keep It Clean Janitorial Services and Supply Company, 403 Samuel Street, Hamilton, New Jersey 08610 is made pursuant to advertisement, be and is hereby accepted, as the lowest, responsive, responsible bidder complying with terms and specifications on file in the Division of Purchasing; and

WHEREAS, funds in an amount not to exceed \$36,557.20 have been certified to be available in the following account number: TY'2021, 2-05- -55-5500-834-004 (\$8,483.85), and CY'2022, 2-05- -55-5500-834-004 (\$28,073.35), contingent upon the adoption of the 2022 budget; The City of Trenton shall award this contract for a period of one (1) year from date of award.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to execute a contract with Keep It Clean Janitorial Service and Supply Company, 403 Samuel Street, Hamilton, New Jersey 08610 in an amount not to exceed \$36,557.20 for Cleaning Services at Trenton Water Works Distribution Complex Mulberry and Courtland Street for the City of Trenton, Department of Water and Sewer for the said purposes in the manner prescribed by law.
