**RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO
FOLEY INCORPORATED FOR NATURAL GAS ENGINE MAINTENANCE CONTRACT
SERVICES FOR A PERIOD OF ONE (1) YEAR FROM DATE OF AWARD IN AN
AMOUNT NOT TO EXCEED \$136,696.00 BID 2021-59B**

WHEREAS, one (1) sealed bid was received on September 10, 2021, for Natural Gas Engine Maintenance Services for a period of one (1) year with an option to extend one additional (1) year for the City of Trenton, Department of Water and Sewer, Trenton Water Filtration Plant; and

WHEREAS, this contract is required for preventative maintenance, testing and emergency services for the two (2) natural gas generators located at the Central Pumping Station, to ensure the proper function of both generators. These generators supply power to the pumping stations in the event utility power is lost; and

WHEREAS, the sole bid of Foley Incorporated, 855 Centennial Avenue, Piscataway, New Jersey 08854 is made pursuant to advertisement, be and is hereby accepted, as the lowest, responsive, responsible bidder complying with the terms and specifications on file in the Division of Purchasing; and

WHEREAS, funds in an amount not to exceed \$136,696.00 for items#1-8 have been certified to be available in the following account number: TY'2021 2-05- -55-5500-813-013, from date of award to December 31, 2021 (\$5,000.00); CY'2022 2-05- -55-5500-813-013, January 1, 2022 to date of award (\$131,696.00) contingent upon the adoption of 2022 budget; with an option to extend one (1) additional year from date of award to December 31, 2022, CY'2022 and January 1, 2023 to date of award CY'2023 in the amount not to exceed \$136,696.00 for items#1-8. A resolution must be adopted to exercise the option to extend the contract for an additional one (1) year. The awarded vendor must submit an extension letter holding the price; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to execute a contract with Foley Incorporated, 855 Centennial Avenue, Piscataway, New Jersey 08854 for Generator Inspection and Maintenance Services for the City of Trenton, Department of Water and Sewer, Trenton Water Filtration Plant for the said purposes in the manner prescribed by law.
