





## **RESOLUTION AUTHORIZING EMERGENCY APPROPRIATIONS TO THE CY 2022 TEMPORARY UTILITY BUDGETS OF THE CITY OF TRENTON**

**WHEREAS**, the total emergency temporary resolutions adopted for the CY 2022 year pursuant to the provisions of Chapter 96, P.L. 1951 including this resolution total \$11,395,362.42

**NOW, THEREFORE BE IT RESOLVED, BY THE** City Council of the City of Trenton, (by not less than two-thirds of all members thereof affirmatively concurring) that in accordance with N.J.S.A. 40A:4-20 the following emergency appropriations for Utility Budgets are hereby adopted as follows.
