RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR AN ADDITIONAL ONE (1) YEAR AWARDED TO BORDEN-PERLMAN INSURANCE AGENCY, INC. FOR BROKER INSURANCE SERVICES FROM MARCH 18, 2022 TO SEPTEMBER 3, 2022, IN AN AMOUNT NOT TO EXCEED A FLAT FEE OF \$75,000.00 PER YEAR -CC2020-04

WHEREAS, Resolution Number 20-510 awarded a request for proposal for a competitive contract on June 19, 2020, awarded to Borden-Perlman Insurance Agency, Inc., 250 Phillips Boulevard, Suite 280, Ewing, New Jersey 08618 for the purchase of insurance coverage, insurance consultant services and broker insurance services for a period of one (1) year from September 4, 2020 to September 3, 2021 in an amount not to exceed a flat fee of \$75,000.00 per year with an option to extend year two (2) and year three (3) in an amount not to exceed a flat fee of \$75,000.00 for the City of Trenton, Department of Administration; and

WHEREAS, the City of Trenton, Department of Administration, Division of Personnel has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to exercise the option to extend the contract for an additional one (1) year from date of award to September 3, 2022 awarded to Borden-Perlman Insurance Agency, Inc., 250 Phillips Boulevard, Suite 280, Ewing, New Jersey 08618 in an amount not to exceed a flat fee of \$75,000.00; and

WHEREAS, funds in an amount not to exceed a flat fee of \$75,000.00 have been certified to be available in the following account number(s): CY' 2022, 2-01- -80-8070-683. This contract shall be awarded from March 18, 2022 to September 3, 2022.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to exercise the option to extend the contract for an additional one (1) year from March 18, 2022 to September 3, 2022 with Borden-Perlman Insurance Agency, Inc., 250 Phillips Boulevard, Suite 280, Ewing, New Jersey 08618 in an amount not to exceed a flat fee of \$75,000.00 per year for the purchase of insurance coverage, insurance consultant services and broker insurance services the City of Trenton's active and retiree population of the City of Trenton, Department of Administration, Division of Personnel for the said purposes in the manner prescribed by law.
2. This contract is awarded pursuant to the authority set forth in the Local Public Contracts Law at N.J.S.A. 40A:11- 4.1.
3. This notice of action shall be printed in the official newspaper for the City of Trenton and the Resolution and contract shall remain on file in the City Clerk's office.
