



Councilman /woman CALDWELL - WILSON presents the following Resolution:

RESOLUTION AUTHORIZING THE CITY OF TRENTON, DEPARTMENT OF HOUSING AND ECONOMIC DEVELOPMENT TO ACCEPT AND APPLY FOR GRANT FUNDS FROM THE NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS - NEIGHBORHOOD PRESERVATION PROGRAM (NPP) IN THE AMOUNT OF \$125,000

WHEREAS, the New Jersey Department of Community Affairs- Neighborhood Preservation Program (NPP) provides funds for "neighborhood preservation and revitalization activities," consisting of housing and economic development activities and other neighborhood preservation and revitalization activities; and

WHEREAS, the NPP is open to municipalities and their partner non-profit organizations that currently do not have an active NPP District and that otherwise meet the NPP eligibility criteria in geographically targeted census tracts and block groups as defined online in the interactive DCA Asset Map; and

WHEREAS, the City of Trenton desires to apply for and obtain a grant from the NPP for approximately \$125,000 to carry out a project for neighborhood revitalization in partnership with Isles, Inc; and

WHEREAS, the City of Trenton has determined the project location based on the eligible census tracts to target within Census Tract 9 (neighborhood boundaries- Eastern Border: Rt. 1; Northern Border: Perry St.; Southern Border: East Front St./ Lafayette St; and Western Border: S. Willow St./Peace St. and N. Warren St.); and

WHEREAS, the City of Trenton proposes to focus the NPP on the proposed neighborhood to create a dynamic economic, social, and cultural hub that meets the needs of residents, commuters, and visitors with safe, affordable, healthy housing and recreational and entertainment opportunities; and

WHEREAS, the Mayor and Council of the City of Trenton, County of Mercer, State of New Jersey does hereby authorize the Mayor and/or City Administrator to apply for such a grant; and,

WHEREAS, the City recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the execution of any such grant agreement; and also, upon receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between the City of Trenton and the New Jersey Department of Community Affairs;

RESOLUTION

WHEREAS, the Mayor and Council of the City of Trenton authorizes the expenditure of the required 20% match for this grant opportunity in CY22 City of Trenton Department of Housing & Economic Development operating budget.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the City of Trenton, Mercer County, State of New Jersey that the Mayor and/or City Administrator are authorized to sign the application, the contract, and any other documents necessary in connection herewith to see that the intent of this resolution is carried out.
