



**RESOLUTION AUTHORIZING CHANGE ORDER 5
TO THE CONTRACT WITH LEVY CONSTRUCTION COMPANY, INC
FOR BID2020-49 RENOVATION OF THE READING SENIOR RECREATION CENTER
15 RINGOLD STREET, TRENTON, NJ**

WHEREAS, Resolution 20-487 authorized a contract with Levy Construction Company, Inc to renovate the City of Trenton's Reading Senior Recreation Center located at 15 Ringold Street, in the amount of \$651,600; and

WHEREAS, during the performance of said contract conditions were discovered that requires additional work: 1) Install a rooftop exhaust to ventilate the new limited-use limited application elevator shaft as newly required by the New Jersey Department of Community Affairs Elevator Division. 2) Fully grout the remaining concrete masonry unit cores within the new masonry shaft wall as required by the limited-use limited-application elevator manufacturer.

WHEREAS, the changes will not alter the contract in such a manner as to nullify the effect of the competitive determination of lowest responsible bidder which was made at the time of the contract award; and

WHEREAS, the total amount of the change order is \$31,115.47. Previous change orders have been authorized in the amount of \$41,630.77. The total amount of all change orders to date is \$72,746.24 and the total amount of the change orders is less than 20% of the original contract. The revised total contract amount is \$724,346.24; and

WHEREAS, funds have been certified to be available in Trust Account Year 2020, T-19-20-55-5501-290.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that Change Order 5 in the amount of \$31,115.47 for a new contract in the amount of \$724,346.24 with Levy Construction Company, Inc. is hereby authorized.


