RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION AND EXECUTION OF A GRANT CONTRACT WITH THE NEW JERSEY DEPARTMENT OF TRANSPORTATION FOR THE TRENTON MOBILITY, OPPORTUNITY, AND VEHICULAR EQUITY SYSTEM (MOVES) PROJECT

WHEREAS, the Commissioner of the New Jersey Department of Transportation (NJDOT) advised the Mayor of Trenton that applications for the FY2022 Local Transportation Projects Fund program were available to support an on-demand autonomous mobility system and could be submitted to the NJ DOT; and

WHEREAS, the City of Trenton wishes to submit an application to the NJ DOT for funds from the FY2022 Local Transportation Projects Fund; and

WHEREAS, the application to the NJ DOT for funds from the FY2022 Local Transportation Projects Fund does not require a financial match from the City of Trenton.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Trenton formally approves the grant application for the above stated project; and

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to submit an electronic grant application identified as "LTPF-2022-Trenton Mobility, Opportunity, and-00055" to the New Jersey Department of Transportation on behalf of the City of Trenton; and

BE IT FURTHER RESOLVED that Mayor and Clerk are hereby authorized to sign the grant agreement on behalf of City of Trenton and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.
