**RESOLUTION AUTHORIZING A CONTRACT TO
FOLEY CAT INCORPORATED AWARDED THROUGH SOURCEWELL
CONTRACT NO. #032119-CAT FORMERLY NATIONAL JOINT POWER
ALLIANCE (NJPA) FOR THE PURCHASE OF ONE (1) 2021 CAT 420XE IT
BACKHOE LOADER WITH ACCESSORIES FOR THE DEPARTMENT OF
WATER AND SEWER, DIVISION OF CONSTRUCTION AND MAINTENANCE
CREW PERSONNEL IN AN AMOUNT NOT TO EXCEED \$159,953.00**

WHEREAS, this contract was awarded from May 13, 2019 to May 13, 2023 (no later than the later of four years from the expiration date of the currently award contract or four years from the date that the NJPA Chief Procurement Officer awards the Contract). This contract may be extended for a fifth year at Sourcewell's discretion. SOURCEWELL Contract No.#032119-CAT formerly National Joint Power Alliance (NJPA) was awarded a contract for Heavy Construction Equipment with Related Accessories, Attachments, and Supplies for National Joint Power Alliance (NJPA); and

WHEREAS, this purchase is necessary for the Department of Water and Sewer, Division of Construction and Maintenance Crew Personnel to perform daily and emergency response water utility work in the TWW distribution system as a direct support vehicle equipped with hydraulics, scene lights, etc. for a heavy equipment operator to excavate at the job site. It allows the C&M Crew to maintain and repair water appurtenances in the water distribution system in an effective and expeditious manner; and

WHEREAS, the City of Trenton, Department of Water and Sewer, Division of Construction and Maintenance Crew Personnel will enter into SOURCEWELL Contract No- #032119-CAT formerly National Joint Power Alliance (NJPA); and

WHEREAS, the Department of Water and Sewer, Division of Construction and Maintenance Crew Personnel will purchase one (1) 2021 CAT 420XE IT Backhoe Loader with accessories awarded to Foley Cat Incorporated, 855 Centennial Avenue, P.O. Box 1555, Piscataway, New Jersey 08855-1555 through SOURCEWELL Contract No. #032119-CAT formerly National Joint Power Alliance (NJPA); and

WHEREAS, funds in an amount not to exceed \$159,953.00 have been certified to be available in the following account number(s): CY'2022, 2-05- -55-5500-841-028. This is a one-time purchase.




