RESOLUTION AUTHORIZING A CONTRACT TO SHI INTERNATIONAL CORP., FOR THE PURCHASE OF A CLOUD-BASED MANAGEMENT PLATFORM AND MAINTENANCE THROUGH NEW JERSEY COOPERATIVE ALLIANCE CK04-19-34 FOR A PERIOD OF ONE (1) YEAR FROM MAY 15, 2022 TO MAY 14, 2023 IN AN AMOUNT NOT TO EXCEED \$119,950.52

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey Cooperative Alliance CK04-19-34 for computer equipment and peripherals for a twenty-four-month period commencing on date of award with one (1) twelve (12) month renewal option meeting the requirements of the City of Trenton, Department of Administration. Each participant must enter into their own contract. New Jersey Cooperative Alliance CK04-19-34 has renewed this contract from June 5, 2021 to June 4, 2022; and

WHEREAS, the City of Trenton, Department of Administration has a need to award a contract to Shi International Corp., 290 Davidson Avenue, Somerset, New Jersey 08873 for the purchase of a cloud-based management platform named GovPilot and maintenance that meets the department's requirements through the New Jersey Cooperative Alliance CK04-19-34 in an amount not to exceed \$119,950.52; and

WHEREAS, N.J.S.A. 40A:11-10 (a) (1) permits the City of Trenton to purchase items and utilize the services without the necessity of competitive bidding under the New Jersey Cooperative Alliance; and

WHEREAS, funds in an amount not to exceed \$119,950.52 have been certified in the following account number(s): CY'2022, 2-01- -25-2540-290 (\$53,500.00), and Trust Account, T-03-SP-65-6520-001 (\$66,450.52). The City shall award this contract for a period of one (1) year from May 15, 2022, to May 14, 2023.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order to Shi International Corp., 290 Davidson Avenue, Somerset, New Jersey 08873 in an amount not to exceed \$119,950.52 for the purchase of a cloud-based management platform named GovPilot and maintenance for the City of Trenton, Department of Administration.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
