RESOLUTION AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH THE LAW OFFICE OF TRIMBOLI & PRUSINOWSKI, LLC TO PROVIDE CONTINUED AND ADDITIONAL PROFESSIONAL LEGAL SERVICES REGARDING LABOR AND EMPLOYMENT LITIGATION AND OTHER LEGAL MATTERS FOR THE CITY OF TRENTON FOR A PERIOD OF ONE (1) YEAR FROM JANUARY 1, 2022, TO DECEMBER 31, 2022, IN AN AMOUNT NOT TO EXCEED \$100,000.00

WHEREAS, the City of Trenton has a renewed and additional need for professional legal services regarding Municipal Litigation for the City of Trenton; and

WHEREAS, Resolution Number 22-080 awarded a contract to the Law Offices of Trimboli & Prusinowski, LLC., (referred to as the "Firm") in the amount of \$50,000.00; and

WHEREAS, the increased amount of funds is necessary to sufficiently and properly defend ongoing and reassigned labor and employment matters; and

WHEREAS the amendment for \$100,000.00 for services rendered through December 31, 2022, will bring the total contract amount to \$150,000.00; and

WHEREAS, this amendment shall be awarded to the Firm in an amount not to exceed \$100,000.00; and

WHEREAS, funds for this contract have been certified to be available in the CY2022 Budget in Account No. 2-01- -35-3500-290;

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to amend the contract with the Law Office of Trimboli & Prusinowski, LLC. for the said purposes in the manner prescribed by law.
