



Councilman/woman Sonya H. Wilkins presents the following Resolution:

**RESOLUTION AUTHORIZING AN APPLICATION AND THE ACCEPTANCE OF
A NEW JERSEY HISTORIC TRUST PRESERVATION FUND
HISTORIC SITE MANAGEMENT GRANT TO CONDUCT
A PRESERVATION PLAN FOR ELLARSLIE MANSION IN CADWALADER PARK**

WHEREAS, the Ellarslie Mansion, located at 1 Theater Lane in Cadwalader Park is a significant cultural site designated as an Historic Landmark in the City's Historic Preservation Plan; and

WHEREAS, the Ellarslie Mansion has been home to the Trenton City Museum since 1978 and as such, is an important cultural resource for the City; and

WHEREAS, Ellarslie Mansion is in need of major capital repairs which requires historic preservation expertise and analysis; and

WHEREAS, Ellarslie Mansion as a site designated on the National and State Registers of Historic Places is eligible to receive grant monies from the New Jersey Historic Trust (NJHT) Preserve New Jersey Historic Preservation Fund Program; and

WHEREAS, the City is eligible to apply for a Historic Site Management grant for up to \$75,000.00, with a match requirement of \$25,000.00; and

WHEREAS, funds to provide the required \$25,000.00 match are available in account number C-04-20-70-008J-002;

NOW, THEREFORE, IT IS RESOLVED, by the City Council and the City of Trenton, that the Mayor is hereby authorized to apply for and accept the NJHT grant in an amount up to \$75,000.00 for the preservation plan work at the above-referenced property and execute all documents pertaining to such a grant.




