**RESOLUTION AUTHORIZING PAYMENT FOR A CONTRACT WITH
CARROLL GROUP INC., AWARDED FOR DEMOLITION SERVICES IN
THE CITY OF TRENTON FOR THE DEMOLITION AND REMOVAL OF
CITY-OWNED PROPERTY AT 659-661 N. CLINTON AVE., TRENTON
IN THE AMOUNT OF \$83,269.00**

WHEREAS, a need existed for the emergency demolition services of Carroll Group, Inc. at 659-661N. Clinton Avenue due to a dilapidated structure which created an immanent hazard to the surrounding environment; and

WHEREAS, the property was comprised 2 brick façade row homes with loose bricks, millwork and gutters continually decomposing and falling in the street as well as a tree growing inside the structures with limbs and branches growing out the windows of the second floor; and

WHEREAS, the maximum amount for the contract is not to exceed \$83,269.00 and funds have been certified to be available in Capital Budget Year 2020, Account Number G-SS-20-60-111B-290, and

WHEREAS, the Local Public Contracts Law at N.J.S.A.40A:11-6 provides that "[a]ny contract may be negotiated or awarded...without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety and welfare requires the immediate...performance of services," subject to the award being made pursuant to the manner set forth therein; and

WHEREAS, the official in charge Henry Guarneri, Building Subcode Official, submitted the attached certification that an emergency existed, and that immediate services to remedy the emergency were required.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Trenton, in the County of Mercer as follows:

1. The Mayor is hereby authorized to execute a payment in an amount not to exceed \$83,269.00 to Carroll Group, Inc, 4 Youngs Road, Hamilton, NJ 08618 for emergency demolition services 437 Martin Luther King Jr. Boulevard in the City of Trenton.


