**RESOLUTION AUTHORIZING A CONTRACT TO BUCKS COUNTY INTERNATIONAL, INC., FOR THE PURCHASE OF CITY-WIDE SERVICES FOR MAINTENANCE AND REPAIRS OF HEAVY-DUTY VEHICLES, DUMP TRUCKS AND SANITATION TRUCKS FOR VARIOUS DIVISIONS FOR THE CITY OF TRENTON FROM APRIL 8, 2022 TO NOVEMBER 20, 2022 THROUGH NEW JERSEY STATE CONTRACT NO. T-2108 89266 IN AN AMOUNT NOT TO EXCEED \$105,000.00**

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-2108 89266 for Maintenance and Repair for Heavy Duty Vehicles (Class 5 or Higher, over 15,000 LB GVWR) awarded to Bucks County International, Inc., 134 Old Oxford Valley Road, Langhorne, PA 19047. The State of New Jersey has awarded this contract from July 21, 2015 to November 20, 2022 as the requirements of the City of Trenton, Department of Public Works, Division of Solid Waste, Division of Public Property, and Division of Streets; and

**WHEREAS**, the Department of Public Works, Division of Solid Waste, Division of Public Property, and Division of Streets will utilize this vendor for the maintenance and repairs of heavy-duty vehicles, dump trucks, and sanitation trucks for various divisions; and

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items and provide services without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the City of Trenton, Department of Public Works, Division of Solid Waste, Division of Public Property, and Division of Streets would like to utilize this vendor for the maintenance and repairs of heavy-duty vehicles, dump trucks, and sanitation trucks for various divisions Bucks County International, Inc., 134 Old Oxford Valley Road, Langhorne, PA 19047 awarded through New Jersey State Contract T-2108 89266 in an amount not to exceed of \$105,000.00; and
