RESOLUTION AMENDING RESOLUTION 21-400 FOR THE AUTHORIZATION OF THE ACCEPTANCE OF THE SFY21 BODY-WORN CAMERA GRANT PROGRAM: #21-BWC-438 FOR \$234,370.00, FROM THE STATE OF NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY TO UPDATE THE GRANT NUMBER #J-J:6-18-17 TO #21-BWC-438 IN THE FIRST WHEREAS

WHEREAS, the State of New Jersey Department of Law and Public Safety, Office of the Attorney General has been designated to implement the #21-BWC-438 Body Worn Camera Grant Program; and

WHEREAS, the program is a joint effort between the State of New Jersey Department of Law and Public Safety, and the City of Trenton, Police Department to implement the SFY21 Body-Worn Camera grant for the purchase of body-worn cameras, ancillary accessories and storage; and

WHEREAS, the State of New Jersey Department of Law and Public Safety, has offered to provide a grant, in the amount of \$234,370.00 from January 1, 2021 through December 31, 2025 with no required match; and
