

Councilman /woman Kathy McBride presents the following Resolution:

**RESOLUTION AWARDING A CONTRACT THROUGH A FAIR AND OPEN  
PROCESS IN ACCORDANCE WITH N.J.S.A. 19:44 A-20.4 ET SEQ TO  
ROBERTS ENGINEERING GROUP, LLC, FOR ENGINEERING DESIGN AND  
CONSTRUCTION SERVICES FOR THE RECONSTRUCTION OF VARIOUS STREETS  
FOR A PERIOD OF ONE (1) YEAR MAY 20, 2022 TO MAY 19, 2023  
IN AN AMOUNT NOT TO EXCEED \$146,000.00- RFP2022-11**

**WHEREAS**, the City of Trenton, has a need for Engineering Services for the reconstruction of various streets under the (CDBG) road reconstruction project for a period of one (1) year for the City of Trenton, Department of Public Works, Division of Engineering; and

**WHEREAS**, the city's FY'22 CDBG road construction program consists of roadway improvements which includes resurfacing and /or reconstruction and elimination of roadway ponding, curb and sidewalk improvement as well as ADA improvements where necessary; and

**WHEREAS**, a request for proposal was advertised, and three (3) sealed proposals were received on April 19, 2022 in the Division of Purchasing, the proposals were reviewed and scored and were evaluated by a committee based on criteria that included experience, understanding of requirements and cost; and

**WHEREAS**, the proposal of Roberts Engineering Group, LLC, 1670 Whitehorse-Hamilton Square Road, Hamilton, NJ 08690 was deemed to include the necessary qualifications and expertise for the performance of the services; and

**WHEREAS**, funds in an amount not to exceed \$146,000.00 have been certified to be available in the following trust account number: T-19-22-26-2500-290. This contract shall be awarded from May 20, 2022 to May 19, 2023.

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Trenton, as follows:

1. The mayor is hereby authorized to enter into a contract with Roberts Engineering Group, LLC, 1670 Whitehorse-Hamilton Square Road, Hamilton, NJ 08690 in an amount not to exceed \$146,000.00 for reconstruction of various streets (CDBG) road reconstruction project from May 20, 2022 to May 19, 2023 the City of Trenton, Department of Public Works, Division of Engineering.
2. This contract is awarded pursuant to the authority set forth in the Local Public Contract Law at N.J.S.A. 40A:11-5.
3. A notice of this action shall be printed once in the official newspaper for the City of Trenton and the Resolution and contract shall remain on file in the City Clerk's Office.




