RESOLUTION EXERCISING THE OPTION TO EXTEND THE NEGOTIATED CONTRACT FOR AN ADDITIONAL ONE (1) YEAR AWARDED TO POOL BOYS POOL & SPA, LLC IN AN AMOUNT NOT TO EXCEED \$75,000.00

WHEREAS, Resolution Number 21-410 awarded a negotiated contract on October 7, 2021, to Pool Boys Pool & Spa, LLC, 116 Vetterlein Avenue, Hamilton, NJ 08619 to provide on-call swimming maintenance for five (5) public swimming pools for a period of one (1) year from July 1, 2021 to June 30, 2022 in an amount not to exceed \$75,000.00 with an option to extend one (1) year in an amount not to exceed one (1) additional year for the City of Trenton, Department of Recreation, Natural Resources, & Culture; and

WHEREAS, N.J.S.A. 40A:11-15 provides that services contracts may be extended for no more than one (1) two-year or (2) two on-year extensions; and

WHEREAS, the City of Trenton Department of Recreation, Natural Resources, & Culture has determined that the vendor has performed its services in a satisfactory manner, and it is in the best interest of the City to extend the negotiated contract to Pool Boys Pool & Spa, LLC, 116 Vetterlein Avenue, Hamilton, NJ 08619 for an additional one (1) year from July 1, 2022 to June 30, 2023 to in an amount not to exceed \$75,000; and

WHEREAS, funds in an amount not to exceed \$75,000.00 have been certified to be available in account number: CY2022 2-01- -70-7025-290- (\$37,500.00), CY2023 3-01- -70-7025-290- (.37,500.00) contingent upon the temporary/final adopted budget for CY'22 and CY'23.

NOW, THEREFORE, BE IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to extend the negotiated contract for an additional one (1) year awarded to Pool Boys Pool & Spa, LLC, 116 Vetterlein Avenue, Hamilton, NJ 08619 in an amount not to exceed \$75,000.00 for the City of Trenton, Department of Recreation, Natural Resources, & Culture.




