**RESOLUTION ACCEPTING A BID AND AWARDING A CONTRACT TO
GARDEN STATE LABORATORIES, INC. FOR SEWER UTILITY LABORATORY
ANALYSIS OF SOLID WASTE AND WASTEWATER FOR A PERIOD OF TWO (2) YEARS
FROM JUNE 3, 2022 TO JUNE 2, 2024 IN AN AMOUNT NOT TO EXCEED \$101,370.00
AT \$50,685.00 PER YEAR BID 2022-27**

WHEREAS, one (1) sealed bid was received in the Division of Purchasing on February 25, 2022, for Sewer Utility Laboratory Analysis of Solid Waste and Wastewater for a period of two (2) years with an option to exercise the contract for an additional two (2) years for the City of Trenton, Department of Water and Sewer, Sewer Utilities; and

WHEREAS, the sole bidder, Garden State Laboratories, Inc., 410 Hillside Avenue, Hillside, New Jersey 07205 is made pursuant to advertisement, be and is hereby accepted, as the lowest, responsive, responsible bidder complying with terms and specifications on file in the Division of Purchasing; and

WHEREAS, funds in an amount not to exceed \$101,370.00 (see attached breakdown of pricing for items#1-17) have been certified to be available in the following account number: CY' 2022, 2-07- -55-5500-290 (\$50,685.00), and 3-07- -55-5500-290 (\$50,685.00) contingent upon the temporary and final adoption of CY'2022 and CY' 2023 budget. This contract shall be awarded for a period of two (2) years from June 3, 2022 to June 2, 2024; with an option to exercise the contract for two (2) additional years for the same amount in an amount not to exceed \$101,370.00 at \$50,685.00 per year. A resolution must be adopted to exercise the contract for two (2) additional years and the bidder must submit an extension letter to extend the pricing and services for two (2) additional years; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to execute a contract with Garden State Laboratories, Inc., 410 Hillside Avenue, Hillside, New Jersey 07205 in an amount not to exceed \$101,370.00 at \$50,685.00 per year for Sewer Utility Laboratory Analysis of Solid Waste and Wastewater for a period of two (2) years with an option to exercise the contract for an additional two (2) years for the City of Trenton, Department of Water and Sewer, Sewer Utilities for the said purposes in the manner prescribed by law.
