RESOLUTION AUTHORIZING A CONTRACT TO LAW MEN SUPPLY COMPANY OF NEW JERSEY FOR THE PURCHASE OF AMMUNITION FOR RANGE QUALIFICATIONS FOR POLICE OFFICERS AWARDED THROUGH NEW JERSEY STATE CONTRACT NO. 17-FLEET-00740 IN AN AMOUNT NOT TO EXCEED \$70,000.00

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. 17-FLEET-00740 for the purchase of ammunition and related police equipment awarded to Lawmen Supply, 7115 Airport Highway Road, Pennsauken, NJ 08109 as the requirements of the City of Trenton, Department of Police. The State of New Jersey has awarded this contract from May 15, 2019 to May 14, 2023; and

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the City of Trenton, Department of Police has a need to utilize New Jersey State Contract#17-FLEET-00740 awarded to Lawmen Supply, 7115 Airport Highway Road, Pennsauken, NJ 08109 for the purchase of ammunition for range qualifications for police officers mandated by the attorney general's office; in an amount not to exceed of \$70,000.00; and

WHEREAS, funds in an amount not to exceed \$70,000.00 have been certified to be available in the following account number: CY'2022, 2-01- -50-5000-333 and 3-01- -50-5000-333. This is a one-time purchase.

NOW, THEREFORE, IT BE RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order to Lawmen Supply, 7115 Airport Highway Road, Pennsauken, NJ 08109 in an amount not to exceed \$70,000.00 for the purchase of purchase ammunition for range qualifications for police officers mandated by the attorney general's office for the City of Trenton, Department of Police.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
